ICC-lawcase against Dictatorship the Netherlands

International Criminal Court in The Hague (ICC) is guilty of racism & corruption. There'll never be peace in Africa or on any other continent due to the fact that EU-leaders, civil servants, police-officers, judges & prosecutors have given themselves 'a licence to kill'.

The office of the Prosecutor (OTP) of ICC 'gives himself a licence to kill too'. OTP protects EU-governments - who donate money to ICC for lawcases against dictators in Africa - from painful trails and imprisonment on demand of EU-civilians against these EU-leaders.

ICC chooses 'who to live and who to die', in exchange for money of powerfull Europeans.

NL & EU are both dangerous dictatorships in World War III; true causes are hidden by the media. Fun-killings are a normal daily activity here. Tolerance is synonym for corruption.

On 1 may 2007, I brought my lawcase against the Dutch supreme court, parliament Balkenende I-IV & municipal Bloemendaal to the prosecuter mr. Serge Brammertz of the International Criminal Court in The Hague.

NL is supposed to be a state of law, but in fact 'a psychopatic Lord of the Jungle is in command in my life and in EU'... and tries to kill me.

Municipal Bloemendaal claims 'that implementation of human rights is no responsibility for the municipal'. In other words: ' We treath you and your young kids like our slaves and have no intention to change this; we ignore all the lawcases your brought to trial and the resulting verdicts. We torment you and we love it. As long als de media doesn't discover us, we continue'.

Members of parliament should have put Bloemendaal under legal restraint, because they prove to be slave drivers. But they didn't. The civil servants who torture me should have been fired and be replaced with servants who aknowledge that they're obliged to implement laws & treaties on a daily basis for all inhabitants of the municipal. The Dutch supreme court should have judged on my file – my case against the municipal & parliament - but they refused without giving a reason. The Dutch S-judge appears to be a terrorist towards Dutch poor people who can no longer defend themselves with legal constructions. Corruption between the court and the parliament, must be the main cause.

Based on the Statute of Rome, ICC is the only court left on planet Earth which can turn dictatorship NL into the state of law NL. ICC is now in a position to save many lives, all around the World.

As you can read on www.desireestokkel.nl ICC send my an email in which they state: 'The prosecuter will get back to you'. But, I still don't know how ICC will procede on my file. It makes my nervous: I have no rights, no money and no way out ... I can't trust ICC now our S-judge appears to be a member of the Dutch EU-pro-war-lobby.

NL is hostcountry for the location of ICC. How can ICC be independent & professional in the corrupt NL-bureaucracy?

I'm the first NL-European who brings a case to OTP, which is only possible because I've evidence. In Holland politicians or civil servants may be dictators because the S-judge creates this opportunity exclusively for them!

Our S-judge-judges with sovereign authority have poor people and their lives removed from community, by ignoring the lawcases they bring to trail.

This is forbidden by law!

- Grondwet, artikel 17 = niemand kan tegen zijn wil van de rechter afgehouden worden.
(Nobody can be kept away of a court-judge against his / her wil.)
- Wet algemene Bepaling stelt in art 13: De rechter die weigert recht te spreken, onder voorwendsel van het stilzwijgen, de duisterheid of de onvolledigheid der wet, kan uit hoofde van rechtsweigering vervolgd worden. Nu moet deze vervolging wel door de HR zelf worden beoordeeld, wat Hitlerrecht is.
(A judge who refuses to judge is guilty of a crime. Unfortunately, the S-judge is the only available court 'who decides of a judge is a Hitler-judge'. In my case they ignore me. An act of terrorisme according to Lawbook for Criminal Court.)
- Wetboek van Strafrecht: Artikel 83 & 83a = Misdrijven beschreven in het Wb vStr zijn een daad van terrorisme zodra uitgevoerd met een terroristisch oogmerk = Onderterroristisch oogmerk is verstaan 'de bevolking of deel der bevolking van een land ernstig vrees aanjagen, dan wel overheid of internationale organisatie wederrechtelijk te dwingen iets te doen, niet te doen of te dulden, dan wel de fundamentele politiek, constitutionele, economische of sociale structuren van een land of internationale organisatie te ontwrichten of te vernietigen. (Terrorism is 'force down fear, aggression, slavery, lawless life on individuals, with the intention to disrupt or destroy the constitutional, economical or social structures in out contry or abroad.

Simple poor people are forced to have themselves killed = being mobbed to death by a growing group of servants who know that they don't have to appear in court...ever...

Dangerous Holland 2007

In theory, in Holland everyone can go to court and protect oneself against increasing violation of HR on the human body caused by members of parliament, civil servants or organisations.

The Statute for the Kingdom of the Netherlands, Constitution, Laws for legal organisations & Treaties declare that NL can never be in a Hitler-war again. Corruption within the legal system may not be possible.

In practise, one doesn't know how to protect oneself against the growing civil war in NL. Due to corruption in politics, legal system, business & media. Since 1980, people haven't learned how to use legal constructions to prevent Holland from becoming a dictatorship again. The lower-class (LC) prefers the victim-role and obeys the Lord of the Jungle who is in command in every municipal, department or parliament. The powerfull upper-class (UC) grows in personal megalomania and hatred towards the lower onces. UC kills UC too.

The government states daily in the media: 'we're democracy & state of law', what doesn't mean that we've a legal system that protects victims of a civil war in NL.

The media presents political manipulations, no legal truth.

Dutch behave like a group of stupid robots, who believe they've no controle over the government, legal system or business. Due to this attitude, the legal system works in favour of those with money, status quo and a pokerface. Good laws are about to disappear or to be rewritten by the government. Dangerous!

The media decides in this proces which part of the legal system is important for quality of life = what to broadcast, what to hide. They turn life into a pleasure yacht = persons who are willing to be a participant in theis 'hunt for fun' have access to the media. Others can drop death.

Social entrepreneurship doesn't exist anymore.

Most of the original Dutch XL-oversized compagnies are now merged with onces abroad. Dutch Small businesses are not appreciated by parliament, universities, AVOs, NGOs or media.

Once Holland was a 'knowlegde-economy'.

Nowadays NL is: 'I want a licence to kill without imprisonment-economy'.

NL is no longer a welfare state and state of law with polite inquisitive residents maintaining nobel features for saving planet Earth from genocide

NL has:

- poor people: unemployed + volunteers + elderly + disabled
- 600.000 kids who grow up in poverty out of 16.5 million residents
- working-poor
- working-middle-class
- working-management
- spioit onces who behave like narcistic crude manipulative monsters

NL has many circles of corruption with destuctive power, some are:

- President of the court, court, office of the prosecuter, police-office, municipals, lawyer's office, politics, schools for higer education, universities & media
- Bussines-market, AVOs, politics, NGOs, media, education, media, VIPs and on top of this the legal system

'Knowledge-economy'

After World War II the Dutch rebuild the country.

- 1960. Technology became available within simple households. Kitchentools manufactured in Holland. Watermanagement and technology. Building a social security system.
- 1970. 'Life was fun', people had overcome severe pains from the past. The economy was growing, we needed guest workers for our dirty jobs.
- 1980 & 1990. businesss were to be expanded to other continents. The General management needed a new challenge. Therefore they had to find an excuse=

production costs were lower abroad than in NL.

The only way for expanding business abroad was to make the Dutch unemployed. Introduction of ICT was very helpful; robots were much cheaper than personnel. Housewives didn't have to work in a paid job. After a divorce the single parent received a social security payment.

Childcare-organisations for working-parents didn't exist.

- Companies who wanted to broaden their horizons dumped their workers in an industrial disability insurance. At first, mainly guest workers were dumped or they new how to profit of the social security system on one's own initiative. Later, white redundant personnel was dumped too. 'The Welfare state was born'.

Education for more knowledge during the unemployment-period?

Whatever you like... Read newspapers or watch tv, or so..

Schools for higher education and universities were – and still are – for the privileged, who can accept the conditions of the upper-class in the moment they enrol themselves for 'a life with the working-management'.

In 1980 the majority of the Dutch still believed in social entrepreneurship and individual skills. This disappeared, when companies got lost in their Fata Morgana's abroad and discovered that they were about to be erased from the international business.

In 1990 NL & EU business-people misjudged the skillful Chinese- or Asian people 'who were able to copy everything at very low costs'.

I've read books on labour skills during the Chinese Revolution and understand why China is a booming business now. The Chinese fulfill a small task today, another one tomorrow and cumulate all their skills into a XXL-oversized project in the future. They don't have meetings that last weeks, months, years during which they have to prove 'they know everything better'. Pragmatism.

They're more realistic in setting goals than we are and they work towards it too! And they lie less about violation of human rights.

From 1950 – 1990 NL & EU were famous for this approach too, but megalomania took over. 'Everybody wants to be the working-management'.

We can't manufacture simple goods anymore, now we've the possibility to import them from China. The (working) poor who is willing to fulfil small tasks is humiliated and exploited. They don't get an education for a change in career, don't get paid enough for a life without the interference of the government.

Small Business-managements merge into multinational-managements 'for distributing knowledge and love for globalization'. And for stealing nature, culture and profits from the poor abroad, as you well know. Europeans lost skills needed for small tasks; ICT and unemployment made people stupid. China and other continents manufacture similar goods and services at low costs and export them to Europe.

Everybody happy in Europe?

No, pollution is a threat in 2000-2007

'NL & EU are knowledge-economies, thus we manufacture new knowledge against pollution, slavery & childlabour and stop civil wars on other continents for healthy globalization', is the adage on our marketplace.

NL manufactures – medical and technological - goods and services that must protect civilians all over the World. Personnel needs to be highly educated. A growing economy is the main topic on the political agenda.

'The welfare state can only exist when everybody works with it', is shouted on a daily basis in the media by the government.

Thus what happens?

2 Groups of people are blamed for all that goes wrong in NL:

1. Unemployed or (working)poor don't work hard enough
2. Refugees / guest labours cost too much = they need to be removed from NL or they need to integrate on the labour-market

Both groups can hardly work in a regular job, because the attitude of the government, business & media. They all lie collectively about the individual legal situation of the unemployed or (working) poor and their role in the bureaucracy. Many unemployed – Dutch or foreigners - have no contract rights, no labour rights, no study rights, no childcare, no right on a life without interference of the government, not enough money for taking care of children as one should do, no right to be a full person. When money is invested in them, it's only to make the civil servant more powerful. Or to give the business-World more tax-reductions when they hire a 'stupid person from the LC'.

The investment can be successful for the poor, but usually is isn't.

'To invest in the poor' is a theaterplay, now the governments lies about the amount of jobs in needed in NL.

What happens than? Showtime!

Foreigners are often used by the government 'to prove that NL is non-discriminator who wants refugees to have a good education and nice job'. Indeed, more tax-money is invested in foreigners than in Dutch intelligent mothers/ fathers who live of a social security payment. But in fact, (local) government, business-World and media keep foreigners unemployed too.

While the successes and failures of integration of refugees is shown-off in the media, the Dutch have to wait in increasing poverty for the government to finish their act on integration. UC claims 'NL is a welfare state'. This implies that waiting in poverty under growing hatred can't be painful for LC-individuals involved. The Dutch have to fight in the bureaucracy for the rights a few refugees get free. In the municipal the Lord of the jungle is in command, thus the mayor, aldermen and servants do as they please... when they invest 'good tax money'. Producing showtime to deceive the World with is waisting tax money! But, the government and business-World need slaves.

The rich can only become richer, without caring for the poor.

Only when the poor stay stupid, suffer and start to fight for their HR, the working middle-class can stay at work.

'NL is a knowledge country, thus the middle-class manufactures knowledge, with which they can save the (working)poor or foreigners', is the adage. 'As long as the stupid fight for their HR - while nobody listens - they don't need a job with a labour contract, childcare, study and average salary'.

The government invests more tax money in mobbing the (working) poor to death, than that they give money away for free to LC for a healthy social educational life...

This is only possible thanks to 'the war against terrorism'.

There is no such thing as 'large groups of terrorists in NL who endanger our national security'. We have a few people who get crazy, start to behave like terrorists similar on the internet ... They've to appear in the Criminal court for 'terrorism'. The existence of terrorism is exploited by UC who needs an excuse for destroying the lives of LC. The working-management can stay in control of the country, when the working middle-class doesn't complain to much.

But, one Dutch company after another merges with foreign companies. They're reduced to 'departments of foreign companies'.

Or they're overstocked and export their goods to developing countries for dump prices = they take over the local business abroad at the costs of other civilizations. They don't care, now the government has made sure that there is no legal system left in Holland anymore.

The risk of increasing unemployment amongst the working middle-class becomes visible. In NL 1.3 million people need a job = they receive an unemployment payment or live of the income of their partners. Government, employers, trade unions write in the media in 2007 'that they'll provide in 200.000 new jobs for the unskilled unemployed in the next 3 years'.

And, what about the other 1.1 million persons who like to go to work too? They've to stay unemployed for the ongoing pleasure yacht that takes place in UC. People who don't have access to the regular labour market are made stupid.

Another HUGH problem remains on the international business = people abroad must be in pain too before they demand services and goods, with which they can rescue themselves or be rescued by military sources.

Due to megalomania – and sadistic psychopathic business rituals – NL & EU don't know how to be social entrepreneurs anymore! Holland suffers from münshausen by proxy-freaks!

When you stay polite to these freaks, they'll turn into serial-killers...

EU-pro-war-lobby is a fact !

Ingredients for 'a licence to kill economy'

- Politicians in parliament & municipals who work like clowns in stead of corporations with legal obligations
- Circles of lies about the condition of our NL & EU economies
- Media who enjoys to be the catalyst in wars in stead of a generator for fair trade
- Advisory boards who don't recognize the local LC as intelligent human beings and don't appreciate them for their knowledge
- NGOs who believe that they can save the World without the implementation of laws, treaties & legal constructs = without distributing legal knowledge for LC
- Lazy or illiterate civil servants who work in the bureaucracy and legal system without knowledge on conflict-ending psychology- & communication-skills, laws, treaties and legal constructions.
But, with the cleverness to lie as if fun-killings are a catalyst for peace.
- Business-people who discriminate human beings on social status & income. 'A LC-person can't be intelligent, thus one doesn't have to start talks with those people'.
- Schools for higher educations and universities who turn themselves into the working-management, in order to take place in the pleasure yacht of the media or the laziness and stupidity on the business. Teach students skills is an inferior task !
- Individuals who prefer to complete their life with complaining on violation of HR, rather than going to court to change the situation for once and for all.
- A community that hates children and uses them for status quo and sadistic political rituals
- Groups of 'middle-aged and older' who behave like spoilt selfish monsters = who don't wish to take care of the younger singles / families without money. At the same time, these young need to provide in care for the older, of course.

'Tolerance is synonym for corruption'

Dutch parliament, local government, legal system & media want to be famous and rich, without doing the hard and often painful work for saving human lives and reducing pain in human kind.

Individuals who work within this system feel good about themselves because no one can make them do the hard work needed.

Tolerance: 'Hard work' in this context in a civilization like NL should be:

- Politics, local government, legal system, businesses, AVOs, NGOs & media work like corporations with legal obligations to fulfil, based on the Statute of the Kingdom of the Netherlands, Constitution, National lawbooks, & Treaties.
- Teach people how to take care of their individual legal position and how to share results with each other for improving quality of life.
- Remove life-threatening situations from community, as soon as becomes clear that individuals of groups live without HR in our surroundings.
- Make businesses manufacture fair trade.
- Export knowledge on the good-practices of our legal system, so civil wars abroad can be stopped as well.

Corruption: 'Soft work' in this context in fact is:

- Perform dirty political language-games.
Manufacture HR-treaties to pretend 'you want to protect minorities from a lawless life', but never go to court to make judges actually use treaties in their verdicts to prevent civil wars to take place.

- Be tolerant, a synonym for corruption
Corruption: 'look away when UC behaves like criminals who refuse to use laws, legal construction & treaties in core-business and in relationships with community.
- Steal knowledge, nature, culture and money from the ignorant stupid people all around the World
- Mob people to death when they stand up and start to fight for individual HR
- Manipulate the media = make reporters and talk-showhosts richer than politicians and civil servants are... to make sure that they'll stay stupid and they'll obey you. Newspapers and tv are one in corruption. Make sure that the media only broadcasts for the stupid of LC.

Victims aren't physically and emotionally strong enough to change the situation. UC brings LC into financial debts with political language-games in the media. This is possible when UC is in a political position, ignores the Administrative court and only focuses on the cases for Criminal court.

Civil court is in the news occasionally = NGOs try to protect members from their target groups against violation of the parliament. But their lawyers don't write the correct letters needed, so many cases fail to protect the vulnerable. Social lawyers want to be 'the darling of UC', so they produce many lies for not having to protect the poor against the growing dictatorship NL. NGOs play games.

Once in debt, LC can't go to Criminal- or Civil court anymore without the help of NGOs. LC is forced to fight against fun killings on their body in the bureaucracy without a chance for a better life. Even in NL judges take part in these 'silent killings'. The Administrative judge has a strong authority when it comes to 'conduct HR-treaties in government-policies', but doesn't want to put this kind of power into 'good-practice for the vulnerable'.

When victims try to organize themselves in existing NGOs or trade unions, they discover 'that LC is only welcome if they don't try to change the system from within'.

When LC tries to make UC aware of the serious life-threatening situations the poor live in, they'll be ignored and boycotted by UC-World-reformers.

Victims are too poor to establish new NGOs or small-businesses.

LC starts to fight against this kind of discriminations only to learn 'that the government ignores ALL legal obligations'. They give up. Fear or stupidity. Existing NGOs prefer fame & wealth in the media above HR for all, too! 'Everybody wants to be the working-management in UC', so NGOs don't bring EU-leaders to trial, when they work like dictators.

UC is free to be a mbp-freak and serial-killer. UC is in a position to intimidate and black-mail their LC colleagues and to ignore people in pain in the target groups with their extremely valuable evidence. LC is blackmailed with a lawless life, unemployment and poverty. LC has no self-esteem & -confidence left.

LC can be mbp-freak too, when they want to keep their jobs = LC relies on the system, colleagues and media for protection against lawcases and imprisonment.

People who stick together in this dangerous situation prefer war above peace = don't wish to go through a personality change. They'll go short on knowledge of psychology in a mixture with law & religion.

Famous and rich individuals in more privileged positions give a psychotic opinion in the media on all what goes wrong. Without looking into legal-facts. And without actually sharing skills with LC-individuals.

LC doesn't have the opportunity to improve skills for a better quality of life and environment. UC with knowledge and skills are only willing to share in exchange for good money and fame. Don't share anything for free anymore, especially not with LC.

If they do, it's only to become a participant in the hunt for pleasure in the media.

Results are irrelevant. LC can't pay for an active role in seminars, courses, networks, and professions of UC. They're excluded from education. The government gives tax money to UC for education of LC, which is invested in 'to mob LC to death because poor people are useless and stupid anyway'. It should be invested in social entrepreneurship.

The criminal UC starts to mob LC to death, when they produce valuable knowledge for UC = UC continues to ignore LC who demands a human response and means, while

presenting business-plans and solutions for social entrepreneurships. Which causes pain. LC's proposals for a coöperative approach between UC & LC for new entrepreneurship is laughed away by UC = UC has no intention to start new refreshing social entrepreneurships!

This is acceptable because NL has a healthcare system. Someone in pain is supposed to go to a doctor. But, even in NL een doctor can be to stupid or to expensive! Healthcare workers don't mix legal constructions caused by mbp-freaks with psychological therapy. Psychological help is of low quality.

UC doesn't fulfil legal obligations towards LC. They rather pay for services of other highly skilled UC-professionals for new core business, which will damages LC even more. Victims have to fight harder for humanity.

**'Because NL is a welfare state & state of law there is no need for an investigation on the criminal behavior of UC, when LC lodges complaints with politics, AVOs, NGOs or tries to protect oneself in court'.
A common adage amongst UC's. Even in the legal-system.**

The most dangerous part of Holland is the relationship between parliament, media, AVOs and NGOs. Due to this relationship LC can't present evidence in the media. Or they can put their files on the internet - like I do - but then they'll be ignored by UC. 'you're not polite enough, you don't assimilate to the system'.

Or LC will be intimidated and blackmailed in htei private home by local police..., to close the site.

NGOs behave like 'politicians' instead of 'fighters for peace' = NGOs need to be famous and rich = need to ignore extremely important legal facts of LC for favourism too. 'LC has to stay weak. Stupids may never be intelligent', core-business of many NGOs.

At the same time, the parliament wants to remove lawbooks an legal institutions from community, so LC can't produce new evidence anymore = can't demand their HR in state of law Holland.

Holland is quarrelsome. To start a quarrel is image building?

The Dutch want to be unique, so they don't coöperate for solutions to stop conflicts.

Internationaal Criminal Court (ICC)

ICC wants terrorism and civil wars.

Favourism & hypocrisy.

ICC wants Taylor to stay in prison, so the OTP doesn't inform the press & public on the fact that a Dutch unemployed poor woman brought a case against the Dutch supreme court, parliament Balkenende I-IV & municipal Bloemendaal to ICC on 1 May 2007. ICC doesn't demand a thorough investigation on the activities of our S-judge = ICC doesn't care for the fact our most important court is a terrorist. How many years do the people have to wait for a conclusion & solution?

OTP knows of my website, and they're very much aware of the fact that my information changes the Dutch approach to terrorism.

I think OTP doesn't care for bomb attacks on NL-courts and parliament or so... AIVD doesn't care either, or do they only use me !?

OTP certainly doesn't care for families who live in a EU-civil war.

And don't care for the fact that they use the services of NGOs who refuse to fulfill their own legal obligations.

Don't get my wrong! Charles Taylor belongs in prison.

But so do MP. Jan Peter Balkenende & his Ku Klux Klan, based on my evidence. I want them to be punished now – not in the year 2010 – before I get sick or die.

I want my children to have a normal healthy social life.

I want my life back, want to live as a resident in a state of law.

The Dutch supreme court works like a Hitler-court from WO II.

They don't open all parcels, don't read all files and evidence. Don't investigate the whereabouts of other NL-courts which ignore significant evidence in files, too.

They've non-criminal Dutch civilians and their files removed from community from the moment they wish to start a lawcase against parliament & municipal = they ignore legal rights of LC, what results in a life without HR for individuals involved.

Thus, S-judge gives individuals – rich and poor – 'a licence to kill'.

Laziness and unscrupulousness.

Or they obey orders from parliament & departments. You tell me.

As a poor unemployed woman - handled as a slave by the municipal Bloemendaal and legal system Haarlem - I tried to start a lawcase with the S-judge 3 times in 2006/2007. Refuse to read my file. Refuse to judge in my case, what is forbidden by law.

Thanks to this approach of the S-judge, I can murder anyone I dislike today. I've no legal position anymore. And nobody - politicians, police, prosecutors, mayors, lawyers & judges - will investigate my daily activities. I'm a threat to their freedom, now I can prove NL is a dictatorship. Balkenende should have stopped this process according to the Statute for the Kingdom of the Netherlands = he should have made sure 'that our S-judge is a court for 16.5 million residents and that the S-judge judges on my case against parliament & municipal'.

He refuses, our MP is the most dangerous terrorist in Holland. Why is Balkenende still Prime Minister? NL donates money to ICC.

As an intelligent individual in the democracy and state of law NL, I expect OTP to anticipate on the possible output of my case against Holland. OTP doesn't!

Now, original terrorists will think: 'NL is a lawless country where groups can start their personal criminal business'.

I expect OTP to invite me for some 'serious hard talks' to establish the legal & emotional truth. But they haven't contacted me officially, yet. Strange! Almost as if they want me to publish my file in the web. If they want terrorist- attacks to take place in NL! Besides, OTP is aware of the fact that the mayor of the municipal Bloemendaal has sent the police over to my house, because 'he wanted me to stop publishing my file on the internet'. The mayor authorized the police to intimidate and blackmail me in my own livingroom. He didn't use any proper legal construction, given to me by the 'Wetboek van Strafvordering'.

In an answer to his criminal attitude I went to the Administrative court – as I should do, now I live of a social security payment – but this judge was too lazy to search for the truth either. The Adm. judge already knew of the fact that the S-judge refuses to judge on my file and I had to turn to ICC to stop aggression and slavery on my body. I'm permitted to publish anything on my site.... So, I warned everybody related to this file. They don't care! Thus, OTP rather plays political language-games which damage human bodies of EU and other civilizations, than trying to anticipate on the explosion of civil wars. A typical Dutch behavioral pattern. Balkenende is permitted to continue his work as a dictator all around the World. Only when the media acknowledges what's going on in NL & EU, OTP shall publish the truth.

OTP is a theaterplay. A production to deceive developing countries and the poor all around the World with. I may not judge on the work of the ICC-pre-Chamber or any other Chambers = they haven't received my file yet. First OTP must investigate the truth behind my evidence, before putting it on the desk of the Pre-Chamber judge. How much time do they need for this simple job? We do have telephones, faxmachines and mail delivery services in Holland! Besides, OTP must protect my family from more violence in my home and on our bodies from the Dutch government. So far, they haven't. Which means 'that OTP takes place in fun killings whenever it's convenient to them'. I need protection, which I don't get because Holland is a 'Welfare state'.

In NL people in a powerful position expect 'violence to smelt away like snow under the sun from the moment the perpetrator knows that the powerfulls understand his/her whereabouts'. Thus, the World knows by now that OTP has a lawcase against the Dutch S-judge, parliament & local government, what implies 'that the perpetrators must stop their violent activities addressed to me, at once'. Offenders won't. They're münshausen by proxy-freaks who turn into serial-killers and enjoy to harm my body. They need to be stopped by judges. What happens when I die, without an ICC-verdict? Then all organisations and individuals involved will say: 'See, the problem disappeared by itself'. And, they will be very proud, now they've killed me without being brought to prison.

ICC is a very young court. I know. But this doesn't mean that they're free to decide on 'who's to live and who to die'. They should have published confidence building policies on the ICC-site, to prove to the people in civil wars 'that ICC is an International Court for 6.5 billion individuals who have no national legal system to turn to anymore'. Long before I brought my file to OTP. At the moment they're only focussed on Africa, while residents of EU are victims of civil wars too. Careful! The fact that Charles Taylor enjoys his stay in the ICC-prison doesn't mean that the Africa is protected against violation of HR caused by NL. The Kingdom of the Netherlands is fallen apart in 482 rebellion groups = 482 municipalities and local civil servants behave like rebellions, followed by the business-partners in the regions. Courts of law don't stop this process. Judges expect violence to smelt away like snow under the sun, too. They don't care. Judges have become politicians, especially in the Administrative court.

EU-leaders present a false picture of the way HR are put into action by EU-governments and ICC. Today, OTP is nothing but a laundry-service for EU-politicians and servants who prefer to work like dictators without being brought to trial or put in prison. ICC is used as a cover for dictatorships NL & EU. It's a 100 million euro toy for their employees. People who work for ICC travel to Uganda 'to give workshops to local police-officers on the Statute of Rome', while our Dutch profs. Law & Social-studies – and police-officers – have no idea what ICC stands for. The Dutch legal-system is not familiar with the contents of the Statute of Rome, doesn't know what to undertake in Holland or Europe.

So, individuals who have to fight for their lives with HR in Holland are better informed than politicians and civil servants... A prof. in Law is a servant!

Therefore OTP is guilty of racism and corruption in EU and abroad. Europeans, Africans, Asians, Russians and others tortured and killed because ICC assimilates to much with the political habits of the Dutch parliament.

Racism

'The upper-class kills the lower-class. The only thing that really matters is favourism, not the colour of the skin or nationality. Are you rich and cooperative? Then you may take place in the fun killings.

Are you poor or can't you be an offender? Then you must be mobbed to death'.

At the end of the road, rich kill the rich, too.

They're already murdering each other, with bureaucracy-games.

Look at Europe versus USA, China, Japan, Russia, Africa....

Africa is used as a toy by ICC & NL.

Although Charles Taylor is imprisoned, this doesn't mean that Africa will get their fair trade, healthcare, education, healthy environment. The World Bank and IMF blackmail African-governments into 'not to charge import-taxes on EU goods in exchange for donations'. We all know that EU promises to donate money, but never write promissory notes.

Africa loses control over their internal business. EU-business bring their 'licence to kill' into practice. EU becomes richer by causing bankruptcy on the local African-market. I feel ashamed by this way of doing business. EU should be intelligent enough to produce fair trade....etc...

Africa needs their HR on a daily basis for protecting bodies, in home and at work.

Contract rights, labour rights, educational rights, childcare...etc..

But as long as EU-leaders 'have a licence to kill' - and ICC doesn't stop this process - Dutch government, companies, AVOs, NGOs & media behave like UC-mbp-freaks.

Free to murder all around the World. When EU-serial-killers don't have to prove in daily life in every contract and in court 'that they conduct HR in core-business', they won't do it. The Dutch are not nice people! Wake up.

Africa will turn against us, soon...

Africa suffers from EU-business-life. But, over the past 2 decades Europeans suffer more and more from that same EU-political-game too. Dutch are made and kept unemployed deliberately. Women and children suffer most and are approached like slaves & prostitutes. Just like the disabled, who 'I'd like to go to work in stead of living from an industrial disability insurance. OTP doesn't acknowledge these fun killings in our bureaucracy as a daily activity of UC. It happens of course, but ...

Now OTP is about 'to give Europe a licence to kill every unwelcome individual'.

Think of: The banlieus of France. The highly educated young poor people of Spain without a future. The 2 Germanies, East and West. Belgium is separated in 3 colonies.

Holland is for sale, the unemployed are the New Slaves.

New racism? Kill whoever is on your path and causes you discomfort. Nobody cares!

Corruption

When a court like ICC acts to informal towards their money-suppliers, it's guilty of crimes against humanity. The poor can't buy themselves a procedure within OTP, can't lobby in favour for their protection. The more time and space the European rich get for their lobby at OTP, the lower the risk for them of being brought to trial and be put in the ICC-prison. Mr. Serge Brammertz of OTP assists Balkenende in a Public Affairs game, at the cost of my life.... and many others.

Balkenende wants 'famous government-leaders from all around the World be brought to trial and imprisoned by ICC'. None of them are EU-leaders.

This is a time consuming activity. OTP spends more time on lawcases against leaders from abroad, then on cases brought to ICC by Europeans. They use the services of NGOs for this.

Brammertz puts my file aside - gives Balkenende lots of time to make up a story for his violation of HR - and doesn't care for the consequences of his action.

OTP should have known better, after reading my file!
Of course I will inform the World of the fun killings in Holland, first of all to protect my family. And sure, I don't mind if original terrorists read my file... Why not?
Why do I have to have myself & kids be tormented to death in NL?
OTP-employees are unscrupulous or they're simply not intelligent enough for their jobs.
Chaos.

Corruption means 'look away when serious crimes against humanity take place...and ignore the victim'.

I sincerely hope that ICC will upload and install New Skills for their personnel after the summerholidays, as soon as possible. It would be nice if their Emotional Intelligence is just as refined as mine is!

What, if ICC doesn't prosecute against Balkenende?

There will be WO III. Refugees from war, pollution and lawless lives will be very angry with the European legal system.

When ICC protects Balkenende – and forces me to life without HR too - I make sure that the World understands 'how ICC sacrifices individuals for the psychopathic murder-games of the International Criminal Court'.

We still have our Dutch national laws to educate foreigners with....

I shall not become a terrorist.

Media. No Freedom of Speech in NL

In Holland every organisation in the media is obliged to work like a corporation = prove they give HR to everybody connected to them.

Let's be clear on this. The media wants civil wars and terrorism.

Violation of HR is hidden by the media because many reporters get payed from tax-money. Or reporters are too lazy to read files of individuals, who prove the growing civil war. Press agencies copy each others work, without verification of facts and legal constructions. Besides, they all love the fact that they can brainwash people in a not-so-nice-way. In order to demonstrate 'that they're more intelligent than the average human being is'. Life must be a pleasure yacht for the rich & fame. It doesn't have to be life-saving for people who can't be a member of this yacht-club !

Foreigners often say: 'In Holland everybody may say anything they want to, everywhere'. TV, newspapers and magazines show a country where almost everybody is happy and people don't have to worry about painful life-events anymore. Accept medical patients, nobody lives in pain. Or accept Moslems, is the insinuation of the media after 5 years of hatred against foreigners under MP.J.P. Balkenende in the parliament. But in fact, the media lies about them as much as they lie about the Dutch (working) poor. Nationality and religion are irrelevant. The media is produced by a small group of people who want to be in a powerful position without doing the hard work needed. It's very much 'a nice family that looks after each other' = media-jobs skip from generation to generation. Favourism. Always the same faces appear on tv to discuss the meaning of life. Newcomers or different-thinking individuals are not welcome. This is only possible as long as they choose topics for 'pleasure and sensation' and ignore the people who prove 'life is hell'.

Don't forget! www.omroep.nl is financed with tax-money.

Employees who work with these companies earn often more income than the members of parliament. They don't want to lose their jobs, so 'they're exclusively nice to the politicians and their servants'. They keep politicians, AVOs, NGOs etc... in powerful positions in the news and segregate the poor who suffer from 'the lawless-policies these organisations conduct'. How? Mainly by producing only 'nice news for nice people'.

What you hear, see or read in the media is carefully arranged and censored.

- The media only wishes to socialize with officials of AVOs, NGOs, educational institutes, politics, media or the rich & fame. Perhaps, simple people are permitted to explain their painful life-events for a few minutes. Never do they get enough time to explain and prove the whole truth with legal evidence.
- The media ignores files and lawcases of individuals who prove that AVOs, NGOs, companies, political parties etc... turn NL in a dictatorship. I have sent my file to almost all broadcasters and newspaper and begged them to tell the truth to the public. It concerns billions of individuals, Worldwide! Collectively they decide to ignore me, from the moment my evidence became too powerful with a negative result for Balkenende & Co. They allowed me for a short time to write on forums, but from the moment I proved that reporters assist Balkenende & Co in turning NL into a dictatorship, they banned me.
- The media analyzes a few cases of the Criminal court, less of the Civil court. Mainly the cases which are good money-makers on tv or in the papers. A lawcase may not change the political climate in NL. And, the media prefers to ignore cases of the Administrative court. What results in the situation that the most important court in the bureaucracy, is free to be corrupt. When the media spends time on the work of the Adm. court, they bring a professor on screen. Rarely the civilians involved. Adm.courts ignore evidence of civilians against the civil servants and politicians, when they can prove 'that they're mobbed to death by the local government'.

When you read all my letters in relation to the letters of the municipal and the verdicts of AC, you understand exactly what I mean!
There is no legal-system in Holland! Media doesn't care.

Sorry, you have to translate if for yourself = you may not expect me to translate the evidence I produced in my own lawcase. All the most relevant letters are on www.desireestokkel.nl

People are deceived, kept hostage in poverty & lawless situations, so they can be of inspiration to the civil servants who need a boost in their careers. Human bodies are sacrificed as food to the Devil. Only with violence one can stop these mbp-freaks.

- Emailaddresses of media, AVOs, NGOs, etc. are managed by stupid robots = the ones without psychological or legal knowledge.
They remove every email they don't understand within 3 seconds.
ICT made average people more stupid; only technology-freaks became more intelligent. Working management became lazy and unskilled.
- Small businesses manufacture quality, but they're overruled by the fact that XL-oversized compagnies get all the media attention, usually for free.
They don't get the change to expand Fair Trade.
- 16.5 million Dutch can read, but they don't know what they have been reading. Illiteracy amongst every age, due to the quality of life in social standards. Older onces who didn't go to highschool can't often read, write or listen. Or they can perform these tasks, but they don't understand 'why they don't get their message through'. Use to many dialects.
This has nothing to do with being Moslims or Dutch!
Only the government makes a civil-religion-war out of illiteracy...
Younger onces are 'victums' of low quality education at high schools and 'childrenhatred'. Kids have become gadgets in our community. Adults only want to invest in the pleasure not in the burden, inherent to educate kids.

And of course business-people who can make money out of illiteracy, produce drama's too. For expample. Employers only wish to hire unemployed when they do get extra tax-money for them. And when they can fire them after 1 or 2 years. Why? Whatever the unemployed do it's never good enough. Even when they study, employers find 'something' to have them removed from the compagny. So, employers make personnell redundant during businesses-deals with foreign-compagnies = force them to live of an unemployment payment for large profits and nice journeys abroad. And when the staff is unemployed again, they demand extra money from the parliament for the re-hire of people juste fired. This is not funny! It makes people stupid! Why? Municipals are not intelligent at all! Are no Social entrepreneurs!.... and don't want to change.
Municipals want to be in controle of the brain of the unemployed...
Or only wish to make extra money from business-deals in the region.
Deals for slavery! Municipal promises business 'cheap labour without contact rights for the unemployed, in exchange for more corruption'.

White-collar-bureaucracy grows rapidly, without a legal system to support it. This procedure destroyes the economy. When at least 1.3 million households can't afford to pay bills anymore and are not recqued by judges from slavery, the only way out is to become violent. Unemployed can't buy houses, can't start a family in their twenties. Can't study as they should, now the municipal wants them to be slaves. And can't communicate with UC anymore, because they're banished by UC... When households can't live a normal social life, it's impossible to get a normal job. Employers are reproachfull against unemployed, while employers self cause our business-climate.

Media ignores this HUGH problem for community, while it's the main cause for street-violence or terrorism'.

- The poor are not permitted to take part in the ICT-World.
Let's be clear! Poor people who have it all – digital lifestyle – can't afford to buy apparatus from the unemployment payment!

Or they're lucky, and live in a social municipal....

Government doesn't want to invest in these skills, although employers prefer job applications by email. Adm.court plays with unemployed as if they're toys, when they need a computer. Read my file and verdicts...!

Some municipals give computers to the poor 'because they may no longer live in solitude'. Others don't. According to HR-treaties this kind of discrimination is forbidden. Bloemendaal only invests tax-money in **lawcases** for computers because I want to study, work and take care of my kids.

My kids have learning-difficulties, due to a life in hatred and extreme poverty.

A lawcase takes up 1 year in court. But when the municipal doesn't acknowledge their legal obligations – and want to treat the mother as a slave – 1 case can last 3 years! When you need to repair 'defaults in kids' there's no time to wait.

Bloemendaal thinks it's funny to have mothers and kids fight against their hatred in court, simply because the judges give them these opportunities.

To give a family a computer is much cheaper than to start lawcases!

Media refuses to investigate the amount of money the government wastes on 'bringing children into learning-problems at school, work, healthcare system...and so on'... for fun....

- **Discrimination on social status quo and income is at its worst since World War II. We are back in 1939. Under Hitler the Jews were manipulated daily = they were never sure of money or official documents they needed. Today, every municipal behaves like 'Lord of the Jungle', since the parliament shouts 'municipals are decentralized from the parliament'. All treaties – and especially the treaty against torture – protects residents who are victims of a lawless life! But judges refuse to use treaties in their verdicts...**

Media refuses to analyze the legal constructions that go with these 'new politics' = decentralization without legal constructions.

However, when you use HR-treaties, it's simply impossible to divide Holland into 482 municipals which work like local rebellion groups.

But, as long as the media doesn't pay attention to this dangerous situation, courts are too lazy to protect civilians too.

We all know that terrorists can be highly intelligent rich people, who invest time and money in their future. They can take over the NL-bureaucracy easily, today. How? They accept a job as civil servant, become a member of political parties, mayor, alderman, police-officer. etc... and wait until NL is completely corrupt and stupid. From the day terrorists understand the system, Holland is history.

I've tried to make tv-makers and newspaper reporters aware of the dangerous lifestyle they cause.

When they didn't want to listen – and my first case against the parliament Balkenende was with the Administrative court in Haarlem – I went to the police. The police didn't want to read my file either. Didn't want to talk with me on an intelligent level, not even on the phone.

The police wrote me a stupid letter: 'you can't start a lawcase against the media, when they refuse to tell the truth'. Police and Prosecutors lie! Many famous people start lawcases against the media. They have money and lawyers, I don't.

Besides, the police knows I have a website since november 2005.

Terrorist will read my site... and start to make plans for terrorist-attacks. Don't you think so? Nobody cares.

What proves that 'the war against terrorist is a toy for people in powerfull

positions' = UC wants to be a serial-killer, who needs a target group for their hunt. Thus, 'Moslims are dangerous on the internet' is the slogan. So, the news is about religion and people who don't accept EU as a state of law due to religion. When politicians of civil servant behave like a terrorist who refuses to acknowledge the state of law NL, the legal system provides them with 'a licence to kill'.

Common adage

A Dutch white 'Bijstandsmoeder' can do or write everything she wants on-line.

Nobody investigates the whereabouts of a poor Emotional Intelligent woman, because she is supposed to be a mentally defective woman, who can cause no harm to politics or media.... Amen.

What should the media do? Build HR & psychology into the genes of individuals

Even teachers at schools are about to lose their skills, now the working management wants to rule the World. This procedure needs to be stopped. People want it, accept the working management self = they don't want to lose status quo and income.

In the next 10 years there will be a shortage of 2500 teachers. Media should present EQ & IQ-increasing programs. Based on psychology and legal constructions.

As a teenager I went to business-school. 1978-1986. It was a good school, that saved my life. During my childhood I've been heavily abused. School taught me how to be 'a social entrepreneur'. Unfortunately, those schools have disappeared from our map over the past 20 years. Nowadays education is almost irrelevant = schoolmanagements are more concerned about their personal management-skills, than that they care for the future of teenagers involved.

As a young adult I have read all the available books on psychology in the city-library.

Thanks to a psychiatrist I could leave my parents, rent a room, try to study and work, but information he gave me wasn't complete.

Many books were stored inside my brain.

Then Oprah Winfrey came on tv. Her talk-shows gave sound to the words stocked in my body. I started to use new thinking- and communication patterns. The same goes for DrPhil. TV-education is an ongoing growth-process.

Today? You can see it for yourself!

I only have Emotional Intelligence ... and people run away from me as fast as they can. It's painful. Sick-making. Now I have the answer to many social conflicts, people don't wish to talk with me, because I use (international) laws, I've no college-degree or I'm a Bijstandsmoeder'.

I perform better than many therapists in NL, I can mix emotions with law to end conflicts... Even professors in psychiatry don't want to read my file. Don't want to know how people become violent.... Remarkable! Profs in law don't know what ICC is about. They only want to be 'lazy and famous in the standard media-circle'.

I live in solitude, my EQ is so refreshing. I hate my life...

When I was 17 I tried to commit suicide, should have died according to doctors.

But the universe sent me back...

With what purpose, if people don't want to comprehend the lifestyle I'm forced to live?

I blame the media for 'making stupid robots out of human bodies'.

Have you noticed that the few Dutch talk-show hosts 'who help individuals solve their domestic problems', make fun of these people afterwards?

Some lucky ones get new home decoration, wheelchair or some psychological advice. But when you watch closely, you'll see 'that these survivors are supposed to cry, laugh and be happy on command of producers'.

TV-makers have no intention to build new social structures needed to stop severe social conflicts in our community... over a period of decades...

TV doesn't teach people 'how to be self-supporting in a state of law'.

Self-confidence, self-esteem and self-conscious.... are invisible in Holland.

Oké, I know in Amerika the government puts everybody in jail. Media reports on it. Americans are no saints either, but there's something they're good at, namely: 'to tell the truth about the way individuals are destroyed in political systems... and try to rebuild the people involved over a period of decades'.

On USA-tv you see talk-show hosts, writers, actors or reporters who invest time, personality, lifestyle, money in the future of individuals. Local residents can actually learn something from watching tv. People get the chance to analyze scars in their souls and find a way to heal themselves. May be vulnerable. May learn from their mistakes and turn themselves into a better person.

In Holland 'vulnerable individuals are humiliated and overruled by Upper-Class', from the moment they show their growth-process in vulnerability. People may not be strong-minded without corruption in Holland. UC immediately starts to make money out of LC's pain, without caring for long-term consequences. When you ask famous talk-show hosts: 'Why don't you investigate on the more painful life-events, their answer is: 'making media has to give my pleasure'.

Oké, Oké... I won't lie to you!

Do you know Jan des Bouvriér? An interior designer? He came on tv to advise simple people on home decoration, became famous & rich. Started his own line in furniture, lights, carpets, windowdressing...etc. For individuals with a lower budget. He produces goods that are just (not) affordable for the (working) poor. Jan des Bouvriér works for rich & poor. Although he's loaded with money by now, he still doesn't humiliate the poor when they get a chance to ask his advice on architecture. He was born into poverty....

But, simple people need legal constructions before they can buy a Jan des Bouvriér sofa...! Fair trade would be nice too.... Media should be life-saving.

New political party

When you want to save the democracy and take part in the election with a new political party, you need at least 5 million euro. There is no such thing 'as free publicity for new politicians'. During election time, old-fashion politicians get all the media attention for free, especially when they produce as many lies as possible and fight with each other over these lies. Nobody investigates the legal-truth.

New politicians not only have to pay for publicity, but they also have to defend themselves against hatred spread by media & old-politicians together.

With 5 to 7 million euro you can buy yourself 1 or 2 seats in parliament. You can buy just enough posters and radio-time to broadcast your message.

New NGO with a CBF-certificate

You need at least 120.000 per year.

Yes, even when you're poor and unemployed!

You don't need a CBF-sticker? Then you will be ignored by... the media....

You're an insider of outsider from the media....

When you're IN, you've a licence to kill.

OUT, you're a victims of those with a licence.

Out and Intelligent? As a poor individual you can get a licence to kill too, but it take you 5 years of your live in hell... Where's the exit?

Stupid robots

Most residents say: 'Whatever the parliament does, you can't intervene'. They don't categorize the legal possibilities of our state of law related to their 1-persons-toko. Complain a lot, are not committed to do the hard work needed. Fair or subbornness?

People who only complain are selfish = don't care for the consequences of their approach to conflicts or war. Spoilt rotten monsters. They can be very poor or organized. I offered them my information and time to help them and myself to a better lifestyle. No charge.

They don't want to talk, 'because they're used to their own thinking-patterns and target groups'. Have no intention to change attitudes. Amen.

What's behind this?

- Our community grows old = in 2040 most of us will be 65 years or older. This group behaves like demanders = expect younger ones to fulfil all their needs, while they don't want to give anything back to the families under 50. They claim: 'We have rebuild the country after WOII, so we're entitled to luxury'.

Because I have no contact with relatives, due to childabuse in my youth... I need people to help me give my children a social life'. Especially now I'm being molested by municipal and government for fun. But, others don't want to help me. I live amongst mainly older neighbours. They're rude, spy on me, gossip a lot... but don't want to know my evidence.

Younger families concentrate on their own families & friends. When they go to work, grandparents are baby-sitters in a combination with childcare.

They have no time left for me.

When I try to explain 'that I'm too poor to give my children a normal social life – or even a healthy educational life – they remain silent.

Why? Holland is a welfarestate, so even when the municipal behaves like the Lord of the Jungle, it's not their business.

I live in poverty amongst rich, therefore people think 'that I'm a lucky woman' = I don't live amongst drug-dealers, so I've nothing to complain.

My needs to be a good mother, study & career are of no meaning to them.

Don't wish to acknowledge that the rich take pleasure out of the fact that they can lie about the help they bring to the poor in anonymity.

When poverty grows in suburbs, the World understands what's going on.

Municipals can't hide their methods for discrimination for ever....

Our Dutch 'probleemwijken' exist due to laziness amongst Stupid robots = refuse to take care of their legal position in their 1-persons-toko = refuse to use the few good lawbooks we still have.

Poverty and a lawless life amongst rich can be hidden from the outside World for a very long period of time.

Because Holland is a welfarestate, 'people go to healthcare often'. Loneliness.

Or they want services for which they've paid in their health insurance. Older people want to be sick, for getting attention. So, they expect younger healthy poor families to go to healthcare too.

Children are made sick with poverty and lies about the quality of their lifestyle.

But I can't go to healthcare...

Therapists don't read files and legal evidence of the poor. Their therapy is

worthless to me! Besides, I want to start my own NGO. Study and work, not be sick.

My children need a school-psychologist, they've problems with writing. Judges received evidence from school-support associations, but they didn't do

anything to give my children their children's rights = extra money for a computer and social activities... Judges use my kids as their toys. My children are too lonely

and too introverted. School-teachers & school-support are very good for my kids! They do everything possible to help us, but when the government-violence doesn't

stop... it's almost wasting time, energy and money.

- **Materialism**
I know about poverty from my childhood. My parents couldn't cope their divorce and bankruptcy of business. Didn't accept help from outsiders, became mentally ill. Personally, I need materialism to overcome segregation I live in at the moment. I don't get it, due to the hatred-campaign of the parliament & government towards welfare-families. I don't get a chance and I have no means to make a chance. My ex-husband takes the children every weekend and half of the holidays, but this doesn't mean that I can study or go to work. In Holland 'materialism' is seen as a luxury for the poor. 'As long as you're not being eliminated and get a little money, you may not complain'. Unemployment payments are not linked to 'employability'. thus, the government steals everything they need from the tax-payer. Not all tax-payers hate the poor! But the don't look into the administration of the government or files of individuals, So money is stolen from the poor, the tax-payer doesn't stop it. Stupid robots.
- **Adm.judges of CRvB wanted to be funny = wrote unreadable and worthless verdicts in which they state: 'Under these circumstances D. Stokkel doesn't have to study anymore' = 'She doesn't need a Law-study now she's the first person who starts a lawcase with the S-court against parliament Balkenende, based on Wet Rechterlijke organisatie, artikel 76'. What means: 'Stokkel has to go to the S-court to undo the criminal CRvB-verdicts and ask the S-judge for a new Criminal-verdict against members of parliament. Judges are Stupid robots too! They start to torment the municipal at the cost of my family life. Leave me without HR or money.**

In the meantime, Bloemendaal gets extra money for my study from the parliament since april 2002, but they don't give it to me. According to that study-contract I had to pay for courses at the Open university in 2002 – more then 700 euro's – from the lowest possible income in Holland.

I can't go to CWI labour-office CWI either, because they're not permitted to give my study, due to the CRvB-verdict = CWI can't give me a Jobhunter, because I need HR. Need money for Childcare from municipal Bloemendaal.

- **Under former president Wim Kok women where to be treated with respect and intelligence = she was entitled to a live without aggression and slavery. But, since Balkenende became president, Dutch women are forced to fight for their rights again. Foreigners & refugees get these rights for free = showtime. Even by trade unions....**
- **In Holland, Stupid robots believe that AVOs or NGOs take care of all their needs. Use services – websites – or become a member, if possible and affordable. Stupid robots don't want to know that AVOs & NGOs behave like Stupid robots too! Corruption and laziness. Megalomania. Many poor Stupid robots believe that they will become rich & famous too, when they obey AVOs & NGOs. This is not how the system works.**

AVOs & NGOs assist parliament in writing new HR-treaties with EU & VN. Complainers don't understand 'that to write HR-treaties is not an effective method to end conflicts'. When you need to anticipate on new conflicts or stop the ongoing civil war, you need to go to court and make judges use HR-treaties in their verdicts. Stupid robots don't want to go to court. NGOs go to court, but they don't really want to protect their target groups. Favourism with the parliament is far more important then the human bodies of Stupid robots.

When insiders don't talk to outsiders, there is no one left to correct the working management during violation of HR.

AVOs & NGOs have incestuous relationships with government, media and legal system. For a position of 'monopolist with a licence to kill on planet Earth'. The richer the working management is, the less they stand up to protect HR of simple people all over the World, the less they protest against EU-leaders. Dutch Stupid robots – rich & poor – think they're intelligent. Dream of it! Don't do the hard work needed. Thus Holland is now for sale.... Where is the money to buy us? Where are the weapons to tease us?

Dutch women

I'm the only poor unemployed woman in Holland who knows 'how to get a licence to kill from the legal system'. And I own it...

An unemployed mother who needs a social security payment from the government is a so called 'Bijstandsmoeder'.

Parliament, government, legal-system, bussines, education & media address her like a mentally defective women. She must be a slave, a prostitute and bad mother.

Or, she may be an intelligent woman in the bureaucracy but then she must prove that she's intelligent enough to protect herself & kids against the hatred of at least 20–30 politicians and civil servants in her home.

Without money, social- & business-networks, even without respect of the neighbours.

Politics & bussines in her file, start to mob the woman to death = to find out, if she's clever enough to be treaten like a civilized mother, employee and business-woman.

When slavedrivers think 'the Bijstandsmoeder is good enough to exist on planet Earth, they allow her to become middle-class', is their attitude. Blackmail. Corruption.

Indeed, there'll never be a moment when she is 'good enough'. First she to poor for a role in the corruption. Second, she can't make NGOs & AVOs change policies in favour of her rights and those of her kids.

Now she's to poor to protect herself against increasing mental torture of the UC, she is laughed at untill she dies. By prosecutors and judges, too. The media...

I live in this life-threatening position in Holland.

A slave is somebody who gets a little tax-money because 'Dutch don't eliminate poor'.

Groups of our community say: 'Now individual gets money for free, it's tolerated to start to brainwash them into a slaves; they must work for their money'.

When they want to brainwash, they put lies on the table in the first minute of the conversation. Because the Bijstandsmoeder needs money, the slave-woman must start to defend herself. It's more human to have 300.000 Bijstandsmoeders and their kids executed. Can you explain to my 'why 400.000 new guest-workers have a job in Holland, today...while Dutch women must stay unemployed and life like slaves'?

Believe me, poor people who don't complain are black marketeers. They must have an unknown source of income = babysitting, cleaning, gardening. I don't work on the black market.

Whether a Bijstandsmoeder is intelligent or stupid she 's not welcome in the regular bureaucracy of UC. People don't want to talk with her.

The hatred-policy of the government is very succesfull. Or UC accepts her, but only on the level of the Stupids robots. Keep her stupid, for making a profit out of her lifestyle.

Over the past 5.5 years I learned some valuable lessons

- 'A Bijstandsmoeder is a woman who can't be abused by the government' is the attitude of people. NL is a welfare state, thus what ever happens to the woman... is meant to save her life from discrimination and worse'.
Due to this adage, a woman has to fight for the aknowledgement of her body, dignity, intelligence, the life of her kids....
- As soon as the woman starts to fight 'people think she wants to be a women-rights-activist', so nobody talks to her. An unemployed woman who needs rights has to go to trade unions, AVOs, NGOs or media.... is the assumption. I don't want to be an activist, I 'm a mother and educator. I want to be addressed in a kind, inspiring and fairly way, without a quarrel. I want my HR without having to fight for it from slavery.
- When a Bijstandsmoeder is to poor to pay for the subscription of a trade union, her existence and work is ignored. When she is a member of a unions she also has to pay for activities. To expensive!

Anyway, union-leaders suffer from megalomania and mbp = they don't have to read files from the unemployed, now they're the ones who settle deals with politicians. So, even when the Bijstandsmoeder can find money for her membership, she must stay a Stupid robot.

I send my lawcase on cd to many famous union-leaders. Don't want to read or discuss it. Thus, an unemployed woman must become a terrorist and fight for her rights with violence. Shall I place a bomb with FNV, CNV, SER, MKB...? Labour-office CWI is not intelligent enough but the women I spoke to are nice and helpful = CWI can't give my a jobhunter as long as Bloemendaal torments me.

- AVOs don't talk with a Bijstandsmoeder. She is the lowest of the low residents. UC & LC in office don't wish to be associated with this woman. AVOs are UC in a relationships with politics and want to stay UC. The more intelligent a Bijstandsmoeder is, the more she's humiliated, plundered, and laughed at... When she has valuable legal evidence about the civil war going on in her private life, they steal it and reproduce it as if it's their own work. For there relationship with politics. Relying on the media to hide this truth. Don't care, for the pain the woman is in! AVOs assist politics in 'to destroy families and mob them to death'. Chose to do so. When the Bijstandsmoeder protests against this attitude of AVOs, they tell her: 'You don't have to send us information, it's your own free choice. Or, you can send information, but we have no intention to do anything with it in coöperation / equity with you....Or, they lie: 'We're not authorized to help you out'. AVOs are obliged by our national law to implement HR-treaties for every individual in their core-business.

- In Holland, 2 circles of domestic violence take place.
 1. Amongst people
 2. Between government and people

Amongst people

This is violence that takes place behind the front door of houses. Amongst members of families, with neighbours...etc. Victims of this type of crime can go to the police and legal-system, NGOs like Victum-help, healthcare-system, social-network, lawyers or even church. The quality of the services they get depends on the municipal they live in. The Lord of the Jungle is in command, thus in one municipal a victim is better of than in an other municipal.

Between government and people

This is a dangerous type of crime, that causes aggression amongst people. It's a not-acknowledges type of crime towards families who depend on the services of the welfarestate. I'm a victim of this kind of aggression of the government and legal-system. AVOs & NGOs are usually financed with tax money. The municipal wants something in exchange for all the money they invest in organisations that try to save victims of domestic violence. Favourism. The municipal helps the organisations to cheap buildings and locations, trainings with police and others, nice days out to the cityhall...etc... In exchange for these sweets, the Lord of the Jungle expects a 'chart blanche for their aggression in the houses of the local inhabitants'. Thus, when servants of the municipal are quitly of domestic violence in the files and the houses of families, AVOs & NGOs are supposed to ignore this. They must leave the family in pain. And they do!

AVOs & NGOs simply don't wish to comprehend 'that they're in cooperation with murders'. Don't want to lose valuable tax money, needed for the establishment of their organisation. Only a few Stupid robots are saved from domestic violence. More are killed.

Intelligent Bijstandsmoeders are killed first, on the same day with their kids.

How to get a licence to kill? Do what I did....

- Use laws & HR as you are obliged to do
- Put everything you need down in letters, send these to the wellfarestate
- Be reasonable, ask only what you really need and provide evidence
- Give the government a fair amount of time to respond.
- Accept their invitation for a meeting
- Make sure you know what you want and keep some alternatives in mind
- Prove that you are willing to study, work, take care of personal business be trusting the government = sign contracts if they ask you too.
Even, when you don't have the money to fulfil all your obligations and the government is obliged to give you the money needed
- When the government sabotages the contract, go to the mayor & aldermen, give them again a reasonable amount of time to solve the problem
- If they don't, go to the Nationale Ombudsman = a reliable institue that tries to help victums of bureacracy
- Does the problem still exist? Write an objection to the committe for Objection of the municipal
- Do this without a lawyer. You can take care of you own business, can't you?
- 3-6 months later, you discover that the Committe for Objections is corrupt to the mayor & aldermen, so you start your first lawcase with the Administrative court. Costs = copy the file, send it to court and pay 39 euro for registry + all follow up costs. When you live of a social security payment it demands at least 100 euro.
- Another 9 months later you will receive the unreadable & worthless verdict.
- Back at the municipal you learn:'You are not permitted to discuss the lawcase and verdict'. From that moment you are a slave who lives in mental agression.
- You have to wait for the municipal to come to agreements = they start to intimidate and blackmail oy.
- Stay nice = go to the committee for Objection again.
- Go to the Adm. court again.
- After you received the second verdict of the Adm.judge you must appeal to the higher Adm. court CRvB. Another year will pass by.
- During al your trails the municipal will increase government-violation in you home = will start a psychopatic ritual = make you fight against their lies and psychoses with lawcases. While it's absolutely clear that the local servants have no intention to aknowledge these lawcases and verdicts
- In the meantime you must be 'a good boy or girl' = fulfil all you legal obligation, when possible. Write the correct legal-system down in all you letters to all organisations and civil servants. This means 'repeat yourself over and over again, to make sure you have presented all your evidence, rights and need – including solutions to end the conflict – on the table.
A costly proces! You will end up in financial depts. This is exactly what the municipal wants = they want to break you with more poverty, even by destroying the life of your kids.
- From the moment you discover 'that you're not permitted to discuss lawcases and resulting verdicts with the government', you demand the members of parliament / departments 'to put the municipal under legal-restraint of the parliament' = HR-treaties are needed to stop the dictatorship you live in
- Of course, you will learn soon 'that the members of parliaments are dictators / terrorist themselves' = the don't want the municipal make obey laws & treaties. According to them this is a job for the judge! When you read their letters, you'll find out 'that they don't know whats written down in your file'. Don't read files, don't talk to you! But they do telephone the local municipal...
- On to the Criminal court and the Dutch Supreme court, then
- In all your letters for all lawcases with the Adm. court you've proved that you need the parliament to put the municipal onder lega-restraint to stop the agression & slavery in you provate home
- You have written the Prime Minister, Ministers, AIVD, police, prosecuters and media... Only to find out 'that they don't read your file and have no intention to stop the violence in your life'. You discover 'that they find it funny to see a poor women fight for her family – business rights'.

- Holland is a state of law, so you may not become violent! No, you may not become a terrorist! You must remain 'a good boy or girl'.
- You turn to all universities, AVOs, NGOs, churches or mosques you can find. Most of them will not read your file, not investigate your lawless life, will not speak to you and will have you murdered by local civil servants 'for fun'. Favourism & fear.
- You try to find a lawyer, but only to learn more about corruption in the favour of our highly criminal government. You learn more about the legal-system = there is no state of law and you have to kill a few people 'if they don't obey the law & HR to save your own life'.
- Dump the lawyer and lodge a complaint about corruption with www.advocatenorde.nl. Poor people may not lodge complaints about lawyers.
- Lodge a complaint about the corrupt Adm. judge, who refuses to investigate the truth and refuses to use HR-treaties in the verdict. Or refuses to send your file to the Criminal Judge. When the Adm. Judge refuse to give your file free, you must go to the Supreme court to make members of parliament work in favour of you. Find out that the president of court gives free legal advice to your murders at the municipal, forbidden by law.
- In a normal situation – you have rights and a lawyer – you can start an appeal with the Supreme court.
- In a dictatorship, you have to turn in an appeal with the S-court too, but based on the Wet op Rechterlijke organisatie, artikel 76 = the S-court has sovereign authority to stop the dictatorship in the private life a resident, without a lawyer. The S-court sends members of parliament who behave like dictators in my case to prison. S-court removes all verdicts of the Adm. court from my file officially and refers me to the Criminal court – in another region - for a judgement on the criminal behavior of the local civil servants in the municipal Bloemendaal.
- Discover, the Dutch S-court works like a terrorist = they ignore files of poor people against members of parliament, mayor, aldermen & civil servants.
- S-court refuses to use Wet op Rechterlijke organisatie, artikel 76, without giving a reason for doing so.

Explain to every individual, organisation and court, related to your file 'that you need services of original terrorist when they refuse to give you back your human rights. You need to free yourself from terrorists who work in the legal system & government'.

What happens then?

Suddenly, you get a few rights from the municipal.

Civil servants from the legal system start to ignore you= run away from you as fast they can....

But, you don't want to become a terrorist, so you bring your file to the Office of the Prosecutor of the International Criminal Court.

Only to learn 'that ICC doesn't take terrorist-attacks in Holland very seriously'. ICC-employees send stupid emails, go on holiday, resign their jobs while there are no replacers, give workshops to African victims while Europeans don't know what ICC stands for. Bring African dictators to trial on demand of EU-leaders... and are not in a hurry to start an investigation on the Dutch supreme court, who works like a terrorist'.... Amen.

Congratulations!

You have now received your 'licence to kill everybody who's on your path', from the Dutch legal system.

You have also lost your life and future.

Don't lose your dignity and self-consciousness.

Dutch children

Kids need a new legal frame to build their souls on.

Teenagers need to learn 'what to think under what circumstances and how to act on it'. Kids need to learn to chose in a mixture of psychology, religion and law.

Young adults must start their self-conscious lifestyle in 'a fair trade-economy'.

Adults should provide in this frame anchored in national & international law.

We have to start in Holland because both International courts of law are located here. As long as these courts 'don't care for the legal and psychological position of kids, there's no path left on which we can save childrens lifes'.

Parliament and government hate kids.

So, do business and parents. Media can be nice, but they don't pay enough time to 'kids in trouble and their legal rights and needs in Holland'.

600.000 kids live in poverty, without a chance for a better future.

600.000 households will start in hel in 10–15 years. Stupid robots don't care for this situation. Business mob these families to death, on demand of parliament and government. Intelligent robots have no voice in our community.

Teachers at primary school care! Quality of school education depends on many elements. Most parents still are in a position to look for a school that meets kids needs. Unfortunately there're waitinglists for special schools = schools for mentally ill kids. The local government is in controle of the budget for disabled kids = the Lord of the Jungle decides what quality of life sick kids may have = in once municipal their life is of higher standards than in others = judges don't use the Children-treaty to protect kids against local government-violence.

Working mangement of high schools are not in a rush to find 2500 new teachers.

There will be more school drop outs, while parents have to work to pay for their luxury lifestyle. Parents have no time or skills to educate kids. When they do have time, they're to poor and segregated for poverty.

Teenagers from 12 years on can't get childcare after school, they loaf about the streets and get the blame for everything that goes wrong in neighbourhoods.

Many of them need therapy, which is not available. There're waitinglists or therapists are to stupid = can't mix psychology with law. Mentally ill teenagers are already put into detention centres, while they need to be in a special school or psychiatric hospital.

These kids live without an education or social life.

Personally I don't want to use services of Childwelfare-care anymore.

I contacted www.amk.nl – an organisation where adults can get assistance when they want to save kids of childabuse- .

AMK does not protect kids who are victums of abusers who work with government and legal system.... Didn't want to read my file, after I spoke to them on the phone. Didn't want to protect my kids against corruption & mental torture inherent. Don't want to change their core-business.

I don't want Childwelfare-care to medicalize my kids' live.

Avoid their münshausen by proxy approach = they depent on tax-money donated to them by municipal for location ...etc. In exchange for this gift, they're asked to look away when politicians, servants or even judges are childabusers. And they do!

I don't want to use services of Childwelfare-care of the legal system anymore before ICC has come to a verdict.

I need money to solve my own problems, to buy friends... for example.

As a single mother – without a family t rely on - I need a lot of money to pass corruption and hatred imposd on us.

For a new legal-frame for our community. New social- & business-networks.

First foreigners must help me. Make the Dutch parliament, business & media knowledge that severe violation of HR is going on in Holland, even in the

International Criminal court. Need foreigners to help me build a new legal frame for the future of our kids, Worldwide.

Politics

Always you hear the same excuses from members of parliament 'when life goes wrong'. Their motto is: 'we can't help it, it's not our fault! Stupid robots believe it, panic and complain. Life becomes barbarian again. Parliament breaks down our state of law, increases favourism and corruption by pretending 'that they have no means to change the situation for the better'. ALL 225 dictators in parliament lie, afraid of losing seats.

Clever basterds take part in this EU-pro-war-lobby for personal economical growth. AVOs & NGOs. Normal individuals in democracy and state of law NL? They do exist, but they don't go to court to claim HR for once and for all. Don't make politics works based on national laws & HR.

I give you the available legal construction you can use to claim your HR in Holland, Europe and all around the World. While writing your letters, keep in mind 'that you have to go to one of the International courts of law in The Hague Holland, perhaps'.

I used an already familiar – but never brought into practise – legal construction in my letters to parliament and courts. Because I'm not in a position to walk away from the conflict the government imposes on me in my private life. In addition, the legal system imposes a lawless life on me = First, the Adm. courts want me to go the S-court. Second, the S-court wants me to go to ICC? Or, did they just want to kill me?

Every individual should work with this construction on a daily bases, in Holland! It's not difficult, it's time-consuming. First facts in files, then lawbooks.

Where do you start?

- Statuut voor het Koninkrijk der Nederlanden = all courts
- Grondwet = all courts
- Wet Algemene bepalingen = all courts = a judge must judge in all cases
- Wet Ministeriële verantwoordelijkheid = all courts
- Wetboek van Burgerlijke rechtsvordering = all courts, although the Adm courts refuses to use this lawbook... in favour of their personal corruption!
- Algemene wet bestuursrecht = Adm.Court refers files to Criminal-or Civil court or demands an investigation of the prosecutors-office and comes to an Adm.verdict.
- Gemeentewet = all courts
- Burgerlijk Wetboek = all courts for associations = verenigingen = politieke partijen (a member of parliament must obey ALL laws & HR)
- Wetboek van Strafrecht, titel Ambtsmisdrijven = Criminal court and other courts refer files to the Criminal court. Criminal judge demands investigation of prosecutors-office against the government and individual civil servants
- Wetboek van Strafvordering = Criminal court and other courts refer files to the Criminal court. Criminal Judge demands investigation of prosecutors-office & police-office against the government and individual civil servants
- **Wet op de Rechterlijke organisatie, artikel 76 against members of parliament = Supreme court only, but you have to use this part in a construction you need to get back your HR with - together with Wetboek van Strafrecht, titel Ambtsmisdrijven - in all your letters from the moment you are not allowed to discuss your lawcases & resulting verdicts against the municipal at the cityhall, parliament or departments = You're now a slave and there is no way out...without the use of violence!**
- All HR-treaties = all courts
- Statute of Rome = International Criminal Court

Following text is a part of the legal construction I wrote in my letters to Balkenende & Co, Supreme court & Bloemendaal. (In simple English.) I explain to them:'I live in a civil war, stop it'. Refusal. You find all letters to members of parliament in: Map 2 lawcase against Balkenende and Map 0 start lawcase with ICC.

Statute for the Kingdom of NL = legal obligations for all members of government

- Art. 43 = take care of the fulfilment of HR, freedom, security of law and soundness of government. Guarantee these rights is an obligation of the Kingdom.
- Art. 47 = members of government - Prime Minister, Ministers, statessecretaries - must swear an oath on the Statute of Kingd. NL before they start to work.
- Art. 48 = Balkenende is obliged by legislation and government to work from the statute of Kingd. NL.

Constitution

- Art. 42 - 49 = members of parliament swear an oath on the Dutch constitution
- Art. 90 = they're obliged to use and promote international law
- Art. 94 = treaties are more important than national law
- Art. 131 = the mayor is put in position by a decision of the Kingdom, officially = member of government in assignment of the king / queen
- Art. 132 = constitution states: 'decisions made by municipal-administration can only be nullified by a decision of the Kingdom, executed by members of government = when the municipal-adm. does not obey our laws and damage the country

Wet ministeriële verantwoordelijkheid = responsibility of parliament

- Art. 1 - 4
Prime minister & ministers are responsible for the realization of constitution and other laws, made by the members of parliament. Don't they fulfil this obligation, they're responsible and commit a crime.
- Ministers who sign decisions of the Kingdom are responsible for administration
- Prime minister & ministers guilty of omission of tasks must be judged by the Supreme court, in assignment of the parliament or the people. Parliament first, but when they fail the people can go to court, too.

Gemeentewet = municipal law

- Art. 61 = minister of internal affairs is responsible for the labour-contract of the mayor of the municipal
- Art. 170 = mayor is responsible for municipal-administration; he must act in favour of the municipal and all inhabitants
- Art. 259 - 281a = minister of internal affairs is responsible for all tasks of municipal. When local government fails responsibilities, minister nullifies decisions of the Kingdom, which are not part of the jurisdiction of the Algemene bestuurswet.
- Art. 266 = every decision of the municipal - written for the approval of an official decision of the Kingdom, must be forwarded to the minister of internal affairs

Thus:

A complete local government, who refuse to obey all law & treaties - turn local inhabitant into slaves - must be put under legal restraint of the minister of internal affairs. On request of the individual with a file of the Adm.court... according to the Gemeentewet. When the minister refuses to investigate the situation, the inhabitant has to go to Civil court and make the minister fulfil his tasks. Individuals normally need a lawyer for Civil court.

But when an inhabitant has a file and outstanding lawcases with the Adm.court, ministers must except this as evidence = the municipal refuses to acknowledge the authority of the Adm.judge.

When individuals have no lawyer for this job - no money for civil court - the minister has the obligation 'to protect this lawless inhabitant' based on the statute of the Kingdom of NL.

This means: Minister of internal affairs must fire all slavedrivers, see to it that the inhabitant can go to court with a social lawyer, gets back all HR and gets paid for the damage.

When the minister of internal affairs - together with the minister of social affairs for an unemployed familie - refuse to fulfil these tasks, the Prime minister must intervene... and save the familie of a lawless life.

When all members of government refuse to investigate lawless lives of residents, the Supreme court must stop these 'crimes against humanity'.

When the S-court refuses, without giving an explanation, ICC must stop 'crimes against humanity of the S-court and all government participants involved'.

Wet wet en bijstand = social security payment

- This law must be removed from community immediately.
Balkenende has written it, especially to make **new slaves** out of unemployed. Political parties in parliament refuse to work like corporations, so they don't make the government 'write laws as they should based on realization of HR'. Political parties are hypocrites towards the people during production of new laws. In the media they shout: 'We want a good life for everybody'. In parliament, during voting 'they give the government the benefit of the doubt'= they agree with laws for new slaves.
Leave implementation of HR in hands of municipals, knowing 'that the local government refuses to acknowledge the authority of the Adm. court'. Local government loves this münshausen by proxy game with inhabitants. AVOs, NGOs lie towards the people about 'their individual possibilities on making political parties implement HR' = they should work like corporation too.
- Art.9 = accept every job... Do I need to tell more?
- Art. 76 = minister of social affairs is responsible for the way the municipal-administration works with this law, related to all other legal obligations = minister must stop slaverdrivers.

All human right treaties are not acknowledged as a part of our legal system, based on the Statute of the Kingdom of the Netherlands.

Wetboek van Strafrecht, titel Ambtsmisdrijven = Criminal court against politics

- Art.355 = members of government / parliament who don't obey the constitution or don't fulfil obligations based on the Statute of the Kingd. NL are guilty of crime.
- Art.356 = members of government / parliament can get a 6 month imprisonment or a fine of 6700 euro
- Art. 365 = coercion = a civil servant forces a resident into a certain thinking- of behavioral-pattern when he or she does not want to do.

Thus:

When the government refuses to obey the Adm.court without – as it should – every resident in Holland can skip to Crim. court. In my case there was one major barrier, namely: The Office of the prosecutor in Haarlem refused to read my files and to talk with me on the criminal behavior of Bloemendaal. This made it impossible for the Adm.judge to send my file to the Crim.court in Haarlem. Result: I've to go to the Supreme court and ask the S-judge to send my file to another region.

Wetboek van Strafvordering = obligations of police-offers when they accuse inhabitants of crime

- Art.27 = suspect = someone who is thought to be guilty of crime = persecution
- Art.28 = suspect is entitled to a lawyer
- Art.29 = civil servant who interrogates the suspect must give the suspect freedom of speech + suspect may use state of law NL + suspect may remain silence + civil servant writes down results of interrogation in the words of the suspect
- Art. 30 & 31 = suspect must receive a copy of the file
- Art. 35 & 36 = judge decides 'what to do with the suspect'
- Art.126a = Office of Prosecutor gives a civil servant an official – written – order for the observation of a resident = including situation, legal facts, circumstances, time limits and behavioral-pattern of the servant assigned with the job. This written order must be handed over to the suspect within 3 days after the observations starts
- Art. on the rights of the prosecutor concerning 'the internet'.

- Art 141 & 148 = Prosecutor in charge of an investigation assigns police-officers
- Art. 152 = police-officers from art. 141 & 148 = present an written record of their assignment
- Art. 159 = Office of prosecutor decides 'how to act on collected facts from observations and other evidence'.

Thus:

According to Dutch lawbooks 'it's impossible that municipal, prosecutors, police work like Lords of the Jungle... and intimidate, blackmail families in their own livingroom to make them obey the local war-lords'.

Algemene bestuurswet (Awb) = law to give residents the opportunity to go to the Adm.court.

- Art. 3:3 = détournement de pouvoir = government may only use authority for taking decisions as instructed by law, not otherwise
- Art 3:46 & 3:47 = a decision must be based on arguments & legislation

I have to keep it simple here. When a municipal refuses to obey laws, this is a crime. In the Awb many other articles guarantee civilians their HR.

In my case Adm judges refuse:

- To investigate abusul.
Ad, court Haarlem
The first judge said to Bloemendaal: 'I know you don't give Stokkel all the information she's entitled to; she can't take care of her personal business'.
But in the first verdict, this judge gave Bloemendaal a free choice = end conflict or continue.
The second judge was crude and said: 'Sorry, I can't intervene' = when I lodged a complaint about her with the President of court, I learned that he himself gives free legal advice to the City-board of Bloemendaal = he is corrupt
The third judge stated in november 2004: 'Bloemendaal you want to abuse Stokkel. She can't obey your orders, she doesn't have to obey them'.
Violence on my family increased.
This judge didn't send my file to the Crim. court, because our prosecutor refuses to read my file. Police refused too. This judge knew 'my file was with members of the government, because I wanted the Minister of internal affairs to put Bloemendaal under legal restraint of the government'.
So, he manipulated me to the High Adm. court CRvB in all his verdicts.
- CRvB wrote 2 unreadable & worthless verdicts, that took away all my HR, because they wanted me to go to the Supreme court. For an unemployed mother it's only possible to go to the S-court when she has to fight for her HR against members of government... Wet Rechterlijke organisatie, art. 76.
- Civil servants are not obliged to appear in court.
None of the judges interrogated civil servants in order to stop the torment
None of the judges made sure 'that I have enough money to live on'.
None of them 'protects my kids, what causes learning-difficulties at school'.
None of them allowed me to bring in witnesses = I wanted civil servants to be interrogated and stopped.
Judges even forbid me to use Wetboek Burgerlijke rechtsvordering = officially, I can claim 'that the municipal presents evidence for all their stories'. Bloemendaal manipulated ALL truth in their letters to me, to bring me in a lawless position.
- I tried to make members of government read my file and stop the torture of Bloemendaal with the Adm.court. Highly unusual! the Adm court can say to members of parliament: 'You are in charge of the quality of the Dutch legal system, you must give Stokkel her HR. Stokkel is too poor to go to civil court, so ministers must come to a decision'.
The first attempt ended in a letter from the Adm.court = they wrote me: 'you must get a decision from the members of government, otherwise we are not permitted to write a verdict'. thus, I send this letter to the ministers involved, resulting in refusal.

- I went back to the Adm.court and wrote the judge: 'Balkenende & Co refuse to come to an decision. Read all my letters.' Then the judge wrote me a verdict: 'Oh, this file doesn't belong to the Adm.court anyway'. Meaning: I'm being manipulated into a lawcase with the Supreme court one again....

Media hides this lawcases, resulting in a new parliament Balkenende IV after the elections in 2006. Why? Because I have no famous lawyer to support me and to explain to reporters: 'Desiree Stokkel is a clever girl, saving many lives including her own life'.

Political parties = Burgerlijk Wetboek 2, Rechtspersonen

A few moments of obligation:

- Government = 'rechtspersoon'
- Political party = vereniging = rechtspersoon
- Registered with the Chamber of Commerce
- Every policy, activity or attitude can be nullified by a judge
- Chairpersonen must obey all laws
- Constitutions are reasonable anchored in legal constructions
- Disincorporation by board, members, stockholders, cliénts etc..by a judge, from the moment laws are not implemented

How should our legal system work?

- **Every individual in Holland starts from 'Statuut voor het Koninkrijk NL'.**
- **Skip to 'Grondwet'. Skip to other laws you need. Go to HR. Finish with EU.**
- **Take all written facts from your file, put it next to above mentioned laws.**
- **Describe what you get + what's missing + what you need.**
- **Send a letter to your opponent, in which you explain 'what you need under what circumstances... and how you wish to execute it..'**
- **Come to an fair agreement.**
- **Build up a legal frame.**
- **Don't use laws to break l-frames down, to make each other weak!**

Advisory boards (AVOs)

Friend or enemy?

First you assume AVOs are your friends, suddenly they appear to be your murderer. The word 'murder' is just another word in the dictionary to them. Pain, inherent is irrelevant.

Let it be clear! Every AVO in NL has the obligation to use HR-treaties against discrimination or worse. According to our burgerlijk Wetboek = associations/foundations = verenigingen/stichtingen. And also based on our Statute for the Kingdom of NL and NL-constitution, article 94 'Treaties are more important than national lawbooks'. Valid for every civilian, single or group.

When a Dutch law forbids an AVO to protect a Bijstandsmoeder or other minority against the civil war in their private life, the national law on which the AVO is established must be rewritten or removed in accordance with HR-treaties. In such a case, the constitution of the AVO must be replaced too. A task for an AVO, political party, trade union, NGO, media or judge. Or for the war victim self! They can go to NL-court, on the condition they can find a lawyer to protect them!?

2 Examples of 2 laws which need to be rewritten today:

- **Wet Nationale Ombudsman = Assists civilians with complaints against the government, but NO is not permitted to investigate complaints on courts of law. When judges are free to murder anybody they want to, who can stop the 'licence to kill economy', then?**
- **Comptabiliteitswet 2001 = Algemene Rekenkamer for the accountancy of government & parliament – but they're not permitted to investigate the cash-flow of courts of law. Nobody knows if judges tell the truth about their investments in the legal system. How much does an unreadable & worthless verdict cost?**

So, AVOs in my case enjoy their crude behavioral-pattern they impose on vulnerable families, who can't defend their bodies anymore with legal constructions against abusul by the government.

An AVO for both, government and civilian.

They tried to help me 3 times since 2002. In 2002 NO made sure that municipal Bloemendaal gave my money for nurseryschool for my kids. In their letter NO also explained: 'If you're tormented, there is little we can do'.

In 2006, after I received unreadable verdicts of our highest Adm.court 'Centrale Raad van Beroep', NO read my file.

Conclusion: 'We see that the Adm. judge ignores all your highly valuable letters from the parliament in their verdicts. We are not permitted to investigate the way CRvB works. We can't help you'. When you read the Wet Nationale Ombudsman, you see that this conclusion is correct.

In 2007 Bloemendaal refused to acknowledge all my lawcases against the municipal again, refuses to talk with me about the situation of slavery I live in at the moment. Refused to take care of my tax-papers. So, I had to involve NO again.

- In oktober 2006 I applied for money with Bloemendaal = I need 3000 euro to start my own NGO without a CBF-certificate on HR for teenagers and young adults. I want to educate them on 'how to use laws and treaties. Besides, I can't go to the labour-office and asked a jobhunter to assist me, now the municipal refuses to cooperate. The only way out is to start my own HOME-office. For many single women with kids to start an internet-small-business is a way to earn a living. But, usually unemployed mothers who live of a social security payment are not allowed to start a business at home. Government assumes 'that these women are not capable of starting a business anyway'.

- If a Bijstandsmoeder gets money, it's because she's lucky to meet a civil servant with a social attitude.... Or, she is a foreigner used to set an example.... First Bloemendaal ignores my application. Then they refuse to give my money. My objection is still with the committee of objection of the cityhall. When they're willing to write an order, it will take at least 3-4 months. This committee does what-ever the mayor commands them to do. With this order I have to go to the Adm court again. Useless, now the municipal refuses to acknowledge all existing lawcases and resulting verdicts. Perhaps they will make up a new excuse this time, knowing my lawcase with ICC becomes Worldwide known, one day....
- The cityboard brings me into financial cepts for fun. To punish me, because they want all poor families to leave the rich village Bloemendaal. Inhabitants of this municipal 'have made it in life and they don't want to be related to poverty'. So they say in the media 'there is no poverty in Bloemendaal'. At the same time poverty is worse than in Haarlem, due to denial. It's impossible to leave this community, because there are no rental homes available... and I have no money. And, my children go to a primary school that's good to them! Teachers help us to overcome dyslexic.

I had to contact NO again. Bloemendaal ignored all my lawcases failed with the deduction of my tax-papers. They lowered my payment, instead of dealing with money the tax-office gave me, as they should. Tax-office made mistakes over the past years = they gave me about 125 euro per month. Miscalculation. Bloemendaal didn't correct this. This year the tax-office corrected all mistakes, so I have to repay all my taxes. And Bloemendaal has to pay me all the money lowered on my payment. I can only repay the tax-office after I receive money from the municipal first. Even when I get this money, repaying costs my extra money = interest. At the moment we have no money for all the bills, food, clothes or school.

NO can't help me out, if Bloemendaal behaves like a terrorist. In 2007 they send me a letter in which they state: 'You may lodge a complaint with us against the municipal whenever you believe this is necessary'. This means that Bloemendaal can't kill me in silence....anymore, but the mental torture doesn't stop either.

But, NO doesn't demand a new law in parliament for a new constitution for the Nationale Ombudsman that gives them the opportunity to investigate on courts of law. NO received my lawcase with ICC against the Dutch supreme court, parliament Balkenende & municipal Bloemendaal, but they don't respond 'because it's forbidden by law'. Thus, judges may be serial-killers in Holland! AVOs watch people struggle for life.

They could have saved my life, but they rather keep me in pain because I'm more profitable to them when they take the risk of 'having me killed by the municipal Bloemendaal, parliament and S-judge'. They manipulate me into an ICC-lawcase. Steal my knowledge, use it as if it's their own work, watch me struggle for life... Why? Clingendael is an UC, so I'm the lowest of the low to them.

Complementary, my fights against slavery, gives them the opportunity to write new courses for international politics on a high level. I'm a money-maker to them, a boost in the careers of civil servants.

Clingendael investigates Security-policies of governments all over the World, in a mixture with Energy and Education on a HIGH political level. Clingendael is supposed 'to prevent civil wars from starting or to help the government stop wars'.

How do they deal with me? In April 2006 it became clear that I had to start a lawcase with the Dutch supreme court against Ku Klux Klan Balkenende & Co. Wet op rechterlijke organisatie, artikel 76.

In theory possible, in practice I'm the first person who needs to start this lawcase. So, I send Clingendael my file to warn them and to ask them for their assistance. They ignored me.

Well, I'm in danger and so is Holland, thus I forwarded emails in which I explained my whereabouts. After a few months they started to realize 'that slavery is a serious dangerous business', they used my information in their articles published on their site. But they still refuse to talk with me!
And this is not only humiliating and painful, it's also an act of war. Violation of HR. They should have worked like a corporation, who proves the World that they obey the International law. Oké, Clingendael did a few things for me, sneakily.
When the Dutch S-judge didn't reply on my file, they informed parliament / departments. A back-up.

When the police intimidated and blackmailed me on command of the mayor of Bloemendaal, the situation became more threatening to me. The mayor behaves like a terrorist and there's no legal system to stop it.

- Bloemendaal wants me to remove all my letters to the municipal and their replies to me from my website, without a court order! I may not have 'freedom of speech' according to the municipal. Remarkable!
My site is open since November 2005. I can prove the Cityhall is a terrorist, tries to bring me to silence.
AIVD knows, but doesn't interfere = refuses to talk with me!
I went to the Adm court again, to make the mayor explain his criminal policies in my private life. The Adm. judge didn't want to interrogate the mayor because at that point I couldn't prove 'that the police had abused me in my own living-room'. This evidence came later in a letter from the Head of Police, after I lodged a complaint on the 2 police-officers. Of course, the Head of Police doesn't intervene.
Besides, it was already clear 'I had to go to the International Criminal Court'. The Adm. judge gives me 'freedom of speech', but doesn't protect my family against violence of municipal, police...ect. in this region... Everything that has to do with the abuse is ignored, so aggression and slavery increases. For my kids too!

Clingendael forwarded letters - I wrote to the Adm. Court and Head of Police - to the departments and parliament. When you read my file, you see 'that letters I send to departments are answered by return mail'. Impossible!
Normally it takes 3 weeks or even months for a reply to arrive.
Clingendael speeded up the response by Email-business.
But in these reply-letters departments write: 'We can't help you, correspondence is closed'. What means: 'If the municipal and S-judge are terrorists, we don't care. Go to ICC'.

Conclusion:

Departments/ parliament / Clingendael don't give orders to the municipal and S-judge, but they don't save my life either. They all together have saved my life from torture, by making the case known to the public. Explain the truth on their websites.
Clingendael - in cooperation with departments - watches my fight for my existence, humanity, kids and legal position. They hide this truth for the World... or use it against me behind my back = make me fight even harder for an increase in their cash-flow.
The harder I have to fight, the more spectacular the ICC-trial will be.
nobody cares for the quality of my life!
ICC is no court, but a dirty political game.... What can I do? Call terrorists, to save me.

Who's HIGHER in rank, Clingendael, Ku Klux Klan Balkenende & Co or I ?
Clingendael is funded with tax money.

TNO-labour and TNO-defence could have saved my life too.
They didn't respond at all. After I forwarded them my file, TNO stated in the media: 'Government should do something about the gap between employed and unemployed. The gap grows fast'. I back your pardon!?

TNO is one of the participants on the labour-market who causes this gap!
TNO-labour teaches the government 'how to manipulate the unemployed into death'.

Organize seminars, workshops, courses, company-training for municipals, departments, members of parliament, AVOs, business.... Students are often civil servants 'who need to study unemployment and national security'. Activities are usually funded with tax-money. The poor have no access to these courses, they're too poor.

TNO-defence produces goods & services to stop or prevent wars. Security-equipment, Risks- & Safety reports, Checklists... etc. . The government is a big demander & spender.

TNO dictates the life of the unemployed, but without reading their files or talking to them. They're UC and wish to stay UC, so they only speak through the media to LC.

I'm a big money-maker to TNO too, with my ICC-lawcase against Balkenende & Co. They don't care for my pain in my body = don't want to handle my case in a way my pain disappears. Oh, TNO produces medical technology too.

TNO is 'independent', but they plan their core-business on demand of the government.

From the moment Clingendael & TNO publish the truth about our legal system on their websites based on my evidence, Holland will be a state of law again. All dictators who work in parliament will be fired. Newcomers are warned! Bureaucracy will be decreased = civilians get back their HR. Judges have to work like judges again.

Universities

Only prof Ybo Buruma of the Radboud-university was prepared to talk with me on the phone, about the fact that I'm being abused by the municipal Bloemendaal. And, 'that I have to start a lawcase against the Prime Minister with the Supreme court, to stop my the dictatorship Holland in my home'.

He didn't read my file as he should have. Didn't want to start a survey 'on 482 municipals who behave like Lord of the Jungle and mob individuals to death'. I'm not the only one who lives in this situation, though I'm the only clever person who tries to use all available legal possibilities to stop this hell.

... While I live in the region Schiphol Airport, with a higher risk for bomb attacks! When I asked Buruma: 'What can I do if the S-judges continue to ignore my file against the parliament', he said: 'I don't know'.

All professors of universities are crude against non-criminal poor victims of government-violence. When I have them on the phone, they come up with lies, start to humiliate me, are not interested in consequences of a corrupt legal system.... They don't even want to protect children from civil war. Don't care if poor people have to become violent too, to protect themselves against UC. Not one of the universities or schools for higher education fulfil their individual legal obligations towards their students or people in general. Don't try to keep up the state of law NL, as they should. Discriminate in their lessons, books, media...

Not one professor Law or Social studies knows what the International Criminal Court stands for. Are not familiar with the contents of the Statute of Rome - a treaty that should protect all individuals against a lawless life - especially when national legal systems are corrupt to governments.

- **Except in Europe = here, EU-dictators get 'a licence to kill', due to corruption between NGOs & Int. courts..**

NGOs refuse to work like cooperatives who prove that they fulfil all their legal obligation, during their activities.

Established NGOs have become dangerous narrow-minded monopolists thanks to political EU & UN-deals, celebrities, media, loteries....

NGO-working management rules politics, AVOs, other NGOs, military peace-missions and even International courts. Our ICC turns to NGOs for collecting evidence against African dictators, they bring to trail.

But, at the same time these NGOs refuse to acknowledge my lawcase against PM Balkenende & Co concerning severe violation of HR on a Dutch family. Aggression, slavery & terrorism. They also refuse to acknowledge the fact that our media hides very important lawcases from the public at the Administrative court against our government. I'm not the only one who suffers, I do I'm the only woman who goes to court. I offered all NGOs my file and services for free = wanted to inform them about the dangerous situation we live in, in Holland and the World. Members of parliament enjoy to bring families into a lawless life and terrorism. NGOs in Holland refuse to read my evidence = don't know what members of parliament have written to me or how they manipulate me into terrorism.

Or NGOs do read it, but don't want to work with me = they prefer favourism with the parliament above HR. They want to be famous in cooperation with politics = write HR-treaties to protect civilizations with, but refuse to go to court to make judges use these treaties in their verdict = don't want to be related to poor individuals who are in a lawless position and fight for their HR.

NGO-volunteers and co-workers are reduced to slaves.

Good enough to collect money or do simple jobs. Have not vote in the board.

From every 1 euro 40% is for the working-management. 60% is invested in projects, but 20% of 60 cents goes to the local project-management. About 40 cents is left for people in target groups.

I can't live with this construction, because the NGO-working-management refuses to implement HR-treaties into their policies.

Do you know that they invest their assets / activa on the stock-exchange in funds that destroy HR, cause pollution and illnesses and make developing countries go bankrupt? NGOs refuse to prove to people that they work with legal constructions as they're obliged to, according to our Dutch laws. Thus, they don't teach vulnerable individuals to become self-supporting in our EU-legal system or International courts.

Dutch RK-Church and Vatican are not angry with me, but they're simply not intelligent enough to communicate with me. Can't accept my life in their universe. Can't mixture psychology, religion and law in one text.

- My universe = take a life-event, read books, talk with individuals, talk about religion....and legal constructions you need to end conflicts.

When I watch 'black spiritual leaders' I notice that they always start with the explanation of a life-events that's important to the community in that moment of time. In addition, they take the Bible or other book... and explain what it learns us on a particular situation. Finally, they put both statements for a solution. I feel fine, when I listen to them.

- What do Dutch spiritual leaders do? They want me to be a member of their sect. Take the Bible and start to brainwash me with text. Completely useless to solve any conflict. They don't want to talk about serious legal constructions that are inherent to conflicts. Spiritual leaders are mostly older men or older women. Younger ones 'don't talk about our state of law – or the disappearance of it – with newcomers either. They steal knowledge, use it in the books they write based on the Bible. Lawbooks are never used to end conflicts for the people.

The Dutch Church is in a position to go to court and demand the implementation of HR. Doing so, would save many human bodies, Worldwide. I think they're cowards, who stick to their rigid existence in the lives of the older people in Holland.

Church doesn't analyze life-events, is not being honest about violation of HR of younger people. Moreover, they have become a member of 'the to mob people to death circle in relationships with the rich & fame'... in exchange for donations.

Suicide! They know it, but don't change it...

Members of parliament or Profs of universities, 'who look away during corruption or take part in it themselves', take a seat in the Advisory board of the Vatican. Church discriminates on intelligence and status quo. Intelligent people run away from Church, now they're not entitled to their own interpretation of the universe. This attitude of spiritual leaders causes more deaths, than it saves lives. Our spiritual leader prefers to be on the photo with our famous members of parliament, instead of telling the truth to the people about legal situations individuals live in, thanks to those politicians. Church, prefers to stay friends with dictators, in order to save Holland from becoming a dictatorship. But now they're not intelligent enough, dictators use Church as a cover for more corruption and fun killings.

Rk-Church tried to help me when they learned: 'Poor individuals can't start a new CBF-NGO anymore, not establish NGOs because the poor have not enough money to buy celebrities, mediatic time...etc.'. They announced on www.rkk.nl that CBF is not a fair licence-system anymore.

But, it's still impossible to work together with Church for me; they're not courageous enough to change the system from within and send dictators away. So, they bring the people they want to save in more lawless positions, poverty and civil wars....

They need at least a few years for purifying their bureaucracy. Old-fashion narcissism amongst spiritual leaders & politics. So I'm exiled in a way....

Amnesty International became very angry with me when I asked them: 'Could you rewrite your constitutions so you can investigate the criminal activities of our Dutch judges?' Now I know why! They want to stay friends with Balkenende & co, because they want to bring African dictators to trial with International Courts of Law.

Non-CBF-NGOs who work like trade unions, in favour of disabled, unemployed or other target groups, don't want to read my evidence or talk about it. They say to me: 'We work together with the government and trade unions and don't want to change this'. Or, 'Our lawyers don't want to use these constructions'. And, 'We can't help you'. THUS: they help the government to kill their own target groups.

Are you still with me?

I have 3 solutions

The World need New NGOs who prove to civilizations 'that they obey (international) laws in their core-business, in a New legal Fram to protect people against dicatorships'. Share legal knowledge for free or at costprice.

1. I Need 1-7 million euro to start my own NGO with CBF-licence in tUC.
Media only pays attention to CBF-NGOs, with the result that poor people can't start their own business anymore in Holland or in cooperation with foreign NGOs elsewhere on the World. Established licenced Dutch NGOs produce poverty, lawless lives and civil wars. Worldwide!

When a poor – unemployed – persons wants to be Chair-person of a New NGO, he or she can start to make a promise to CBF = when you want to prove that you are reliable, you can get an aknowledgement of CBF = be registared on www.cbf.nl as newcomer. For this aknowledgement you need to invest at least 35.000 euro in management-costs, with an activa of 120.000 euro per year.
A board of 5 indepent seats is required! Yes, you read it correctly, a 5 seats board in quarrelsome Holland to safeguard the World with!

Poor unemployed people can only start a foundation without CBF, if the municipal gives permission.

For example: The minimum total year-income of a single mother with 2 kids = 14750 euro. Not enough for all costs of living! It's impossible to start a business from this income.

Thus: 1.3 million unemployed poor households in Holland, are excluded from the management of New CBF-licenced NGOs.

It depends on the municipal where one lives = some allow unemployed to start a home-business, others don't. Some unemployed get funds from the municipal, others don't! Parliament & legal system don't want to stop this kind of discrimination = laziness and favourism in the region.

Personally, I need to win my ICC-lawcase, so I can pass the torment of the municipal with the money I get payed for damage. Startbrief ICC 1 mei 2007.

In fact, I need 1-7 million euro to buy a 5 seat CBF-licenced-NGO-board for a position in the current working-management of Upper-Class.

To buy my rights within the International Criminal Court, with.

To buy advertising-time with.

Do you understand me?

2. Without a CBF-licence I need 1 million euro to leave the corrupt bureaucracy behind me and start my own NGO or AVO in the Upper-class.
Have to buy friends ... for a 2 seat board.

3. Or ...

I work from the Lower-class if somebody from the Upper-class is willing to invest in me. Cooperation in equality.

The investor pays the sollicitor for the constitution, Chamber of commerce, bankaccount, compagne-website. In a 2 seat board!

2 Persons to start with = 1 with the money + 1 starts the organisation. This gives me the oppertunity to pass mental torture of Bloemendaal = to start a business on the investment of another individual, while I wait for ICC to start trail against the Dutch S-court, parliament Balkenende I-IV & municipal Bloemendaal.

When an investor starts a new Foundation together with me, Bloemendaal can't stop my from working. I'll be a volunteer, untill we earn 120.000 euro per years for the CBF-aknowledgement ... for becoming a reliable NGO...

I can be a board-member in a New NGO from my current position = an unemployed mother who needs a home-office for an internet-business with an official investor.

We can start to educate young adults on International law.

I can write my book, while I wait for the ICC-judge to give me back my HR in Holland.

Municipal Bloemendaal forces me to go to court and has me fight for my HR, so I have to wait for the ICC-verdict that gives me back my contract rights for a 1-persons-toko in my own name on the bussines-market. I want to be a mother & educator, not a HR-activist. I find it rather pathetic that a civilized country like Holland needs a HR-activist.

Extra remark on Mosques

- Moslms don't understand the true causes of discrimination, because they don't what to coöperate with Dutch individuals who are able to analyze the legal system or corruption in politics. Fair of stubbornness !?
I acknowledge deportation of foreigners = refugees are send into hel by our politicians who don't feel ashamed when they sentence foreigners – and even their young kids – to a 'silent death'. Put them on a plain to be murdered in another country. Fun-killings well known abroad by now.

Moslms often believe 'that they must integrate', so they try to please UC as much as possible in their attitude towards them. Ignorance!
They try to play by the book of politicians, AVOs, NGOs, media and so on...
Moslms don't understand that they'll never have a change on a life in equality with this UC, unless they have money or are being used for positive discrimination. UC doesn't care for LC.
UC doesn't care for UC, when they need to get 'somebody out of the way'.

Result: Mosques don't use the available legal constructions to stop hatred of parliament / government / organisations / individuals against Islam with.

www.elthawheed.nl read my file last year. We talked about it.

They begin to accept the fact 'that they must talk about legal solutions to protect themselves against hatred'.

Mosques must learn to chose the right friends.
Forget about Old-fashion politics, AVOs, NGOs, media.....

I predict: Holland will be a very crude dictatorship soon!

No state of law NL

Parliament and legal system decide together

'Which criminal events to bring to trial and which to hide from the public'.

Make up a list, together with Raad voor Rechtspraak + Presidents of court + Openbaar Ministerie + Raad voor Rechtsbijstand + Politie.

his list is not published, officially it doesn't exist.

Read newspapers & websites and you know 'what's on the list 2007-2010'.

Yes, this time there's nothing wrong with your thinking-pattern =

indeed, severe crimes against humanity are never brought to trial!

Think of:

- **Violation of HR by politicians, civil servants, lawyers, (legal) organisations**
- **Childabuse, incest, neglect of kids, disabled and elderly. Lawless lifes.**
- **Womenabuse. domestic violence between people, and especially not 'domestic violence between government & people'**
- **Medical failures = 33.000 mistakes per year, only 1300 go to court**
- **Pollution...etc...**

You think Holland is a state of law.

- **In the media you read about hugh mistakes police, prosecutors & judges make in murder-cases. Famous & rich criminal lawyers fight for HR of innocent victims in yail, who are send to prison for a murder. Victims of fun killings by judges. As soon as these victims of the legal system come free, they receive a payment for damage.**
- **You also read about a computerized system for paying traffic-tickets.**
- **You know that the Dutch supreme court produces decrees/verdicts within reasonable time for XL-oversized compagnies.**

It looks fair, doesn't it?

Besides, we Europeans write Human Right-treaties, don't we !?

We start millitary ISAF-peace missions all over the World to protect simple people against violation of HR, isn't this true ?

But what you don't know....

- **LC-people don't get a change to go to Civil - & Criminal court for HR, because police, prosecutors, lawyers, AVOs, NGOs & parliament don't read files and evidence of the poor. They make up stories...!**
- **UC-people are destroyed to, when multinationals and government need this.**
- **And the Administrative judge is to lazy to investigates what's going on! The A-judge must interrrogate civil servants in court, send files to the Criminal court, fromt he moment non-criminal individuals in the bureaucracy life without HR.**

Thus, criminal politicians & civil servants who coöperate in 'mob someone to death' simply don't exist in our legal system.

Everybody related to government and legal system - one way or the other - has 'a licence to kill'. Lawyers and professors of Universities for Law, included.

According to our rules and laws on Trias Politica:

- **Parliament & municipal are law-makers.**
- **Members of parliament, mayor & Alderman, Head of Prosecutors, Head of Police, Lawyers-offices & Presidents of Court may not cover each other during violation of HR. Have to correct each other officially in written documents in our state of law.**
- **Legal system is some one who brings law into good practise.**
- **And should AVOs & NGOs - in coörperation with universities and public - controle the system.**

In daily life UC comes together for writing political policies in the favour of their personal criminal behavior... Public and LC are excluded. UC can be excluded, too.

Lawyers

- Famous lawyers use all the mediatime for the Criminal court or business-deals that have to go to the Supreme court. They pretend to rescue innocent victims in their battle for 'a reliable legal system' or pretend 'to protect Holland against corruption'. Their names and reputations are in history-law-books or on www.rechtspraak.nl

But, their battle is not sincere!

They don't do social cases of non-criminal victims, who suffer from government-violence in the Administrative court. A court that's nothing but a laundry-service for with-collar-criminals. Terrorisme in the Adm. court simply doesn't exist!

Lawyers consider the Adm. court to be an inferior court. People who live in a lawless position, due to corruption in the bureaucracy, are not important enough for their reputation of famous lawyers.

Despite 'the War against Terrorism'!

So, innocent people who suffer from Criminal court of S-court must be rescued from a lawless position = they may not be sent to prison for a crime they didn't commit. Holland must stay a state of law.... Not all suspects of crime are terrorists, so when criminals are about to be sent to jail as terrorists...they're entitled to a fair trial!

Of course, famous lawyers know 'that when they ignore victims of Adm.court, they assist the government in fun killings'...

Job-rotation amongst judges:

The Criminal judge today, is the Adm.judge or Civil-judge tomorrow.

Presidents of Court are in a position to put a certain judge on a case or to remove a judge from a case. They use their authority in silence, after they have attended meetings at the Cityhall, where they give free legal advice to civil servants and politicians.

Conclusion:

A famous lawyer, only works for his- or herself. Not for a fair legal system!

As long as the media only pays attention to the Criminal court, famous lawyers only work with the Crim. court. In the meanwhile they also assist the government in 'mob people to death'. Resulting in aggressive individuals in our community, who live without HR and start to commit crimes.

What is good for core-business in the Crim. court!

- Silent layers are hardly in the media. 'They don't do social cases'. I really can't tell if their clients are satisfied with services. Many clients complain about 'the low quality letters lawyers write'. Or, the honorarium they have to pay for those worthless letters. Many conflicts don't end in court = verdicts still have an open end, in favour for one of the parties.

My opinion. When I see what these lawyers accomplish for NGOs and Trade Unions, I think we better close down our Universities for Law.

For example:

Trade union FNV demand a minimum wage for 13-14 years old kids.

The Supreme court writes a verdict in favour of the parliament = young kids fulfil only simple tasks in small jobs, they don't need a position in a collective labour agreement with a guaranteed wage.

What means: 'Every employer may use young kids as slaves'.

Supreme court should have used the Childrens-treaty that states: 'Judges have to judge in favour of kids, have to protect kids first under all circumstances'.

Why doesn't judges use treaties on their own initiative?

They're not forced to do so, by trade unions and lawyers.

The people are stupid robots, unfamiliar with the contents of HR-treaties.

- Social lawyers
The Raad voor Rechtsbijstand is the financial support system for social lawyers. This system promotes corruption. Social lawyers don't read files! They take 1 or 2 letters out of the file...and start to lie against their client. Lie about the legal position, lie about their 'sneaky deals' with the municipal. Lie about the amount of money they make while working for you. Lie about financial procedures.

After a 1.5 year search I finally found a social lawyer who was prepared 'to fight against violation or HR on my body against municipal Bloemendaal'. He made life worse! Forced me into agreements with the municipal, without consulting me. He didn't want to write letters to stop the conflict and give me back my HR, lied in court. Later I discovered that he had worked for the municipal in the region Haarlem-Schiphol. He didn't take my case to protect me; he used me for his corruption. He even tried to steal my money....

When I tried to lodge a complaint on him with www.advocatenorde.nl I learned 'that poor people may not lodge complaints about corrupt lawyers'. I lodged a complaint with www.raadvoorrechtsbijstand.nl only to learn 'that they don't care if tax-money is wasted on corrupt lawyers who make life for the poor hell'. Raad voor Rechtsbijstand didn't want to give me a reliable new lawyer for my lawcase against our PM Jan Peter Balkenende and his Ku Klux Klan, despite the evidence I presented. I learned that the financial support system for social lawyers 'enjoy the fact that up-to-now nobody has discovered that they work like mbp-freaks or serial-killers'. They love the game they play with human bodies! I spoke one of these monsters on the phone. They don't care for the fact that my lawcase is published on www.desirestokkel.nl accessible for every original terrorist....

I decided 'to go further without a lawyer', my letters to the members of parliament were built on a lawless life, anyway. All letters are in the file.

How do I try to get my HR back?

The summary of what happened exactly in all different lawcases is written down in my letter to Prof Ybo Buruma of the Radboud-university. It's in Dutch available on my site. Later, I'll translate it in English. Buruma knows 'that our Dutch Supreme court works like a terrorist, but he doesn't want to investigate on it'. He's not familiar with the contents of the Statute of Rome, doesn't know what ICC stands for...

Important now:

- Members of parliament / departments don't read files of the poor = don't know what judges write in their verdicts related to fact in files. Don't talk with the poor who are victims of a lawless life. Don't want to investigate on municipals who work like 'the Lords of the Jungle, who refuse to acknowledge lawcases and resulting verdicts'. Don't want to investigate abuse, torment, mental torture executed by civil servants, when they refuse to fulfil their obligation based on the Gemeentewet - 'municipal law' - or other lawbooks.
- Members of parliament don't wish to fulfil their personal legal obligations from the Statute for Kingdom NL & constitution, that instruct them 'to guarantee Holland is a state of law for all residents'. They don't care, if
 - Holland has a legal system or not!
 - Poor people have to fight without a 'social lawyer'.
 - Adm. court is a laundry-service to corrupt civil servants.
 - President of court gives free legal advice to the municipal, with a lawless life for residents as a consequence of that act.
 - Raad voor Rechtspraak refuses to investigate on corrupt judges.
 - Head of police, Head of Prosecutors, Advocatenorde and municipal work together in a corrupt system 'to mob individuals to death for fun'.
 - AVOs refuse to investigate 'lawless lives' and produce lies in their reports.

- Individuals 'can't go to court and follow the normal procedure anymore', due to a corrupt legal system.

- Now member of parliament 'don't care' = they're not familiar with the legal construction individuals use in their letters to the government 'to get back their HR'.

In my case, I have used Wet op Rechterlijke Organisatie, artikel 76 from the moment I learned in 2004 / 2005 'that our Minister of Internal Affairs was not willing to investigate aggression, slavery and murder attempt in my situation'. When a municipal is a rebellion group, they must be put under legal-restraint of the parliament – Minister of Internal Affairs – immediately. Especially 'during the war against terrorism' in Holland.

Members of parliament come up with the same lines:
'Go to court'. I back your pardon!? By now I have 51 pages of verdict...
The Adm. court in Haarlem wanted me to go to the CRvB in Utrecht.
The CRvB want me to go to the Hoge Raad.
Thus, both courts write unreadable and worthless verdicts so I must go to the Supreme court 'on Wet op Rechterlijke Organisatie, artikel 76 against members of parliament'.
How many more pages do you need before you start to read them?
Where do I get all the money from?

'Go to the Police'. What do you say?
I have proved to you 'that police and prosecutors refuse to talk with me, refuse to analyze the situation'. The mayor gives the police 'a command to intimidate and blackmail me in my own home, because he wanted me to close down my website...'
Do you ever talk to the police? Do you know that these are 'retarded men and women'? They are not civilized at all! Don't read files, but put on a police-uniform and start to brainwash people in a criminal way.
Work like bank-robbers, porno-freak who demand obedience, instantly. When you can't Obey, they become crude.

Moreover, I can't go to the legal system in Haarlem-region anymore, now I can also prove 'that our Supreme court ignores files when other courts are corrupt...or when they have to judge against members of parliament'.

What do you want me to do, Mister President Jan Peter Balkenende?

You write to my in your letter: 'I don't answer your letter'.

Thus, I explain to you that I live in a civil war in region Haarlem... and the only legal construction you can think of is: 'I don't answer your letter'.

I can't become a member of your Ku Klux Klan, I'm banished by your kind of people... Minister for Internal Affairs, Minister for Social department, Justice department, you all ignore me! Write me letters that prove you don't read files... Besides, I'm too poor to be a participant in your corruption-policy.

I write in 2007 to your Ku Klux Klan:

'I have to start a lawsuit with ICC against the Dutch Supreme court, parl. Balkenende I & IV and municipal Bloemendaal, when you don't investigate the corrupt legal system I live in. I need to get back my HR for a normal lifestyle. You are a dictator.'

I do get a new letter of the Minister of Internal Affairs with the outline:

'We don't care if the S-court is a terrorist, don't care if you are murdered by the Lord of the Jungle'.

Minister and State secretary of Social department don't respond at all.

AIVD, our not-so-intelligent-service. They're racists!

AIVD writes me: 'We are not authorized to investigate your situation, we can't make the Minister of Internal Affairs put Bloemendaal under legal restraint of the parliament'. Why can they investigate on Muslims and not on me?

Forethought

Why start a New Legal Frame (NLF) from Holland against civil wars on planet Earth?

International Court of Justice & International Criminal Court are both located in The Hague, Holland.

You need to understand the way our Dutch legal system works and fails. Need to understand favourism between Dutch parliament, Legal system, AVOs, NGOs and International courts.

- HN-goods & services are cheaper products that destroy the planet!

Home-valuta per address

Every individual is obliged to live in a HN-economy house

- Home-valuta = 600 p. month per household of 4 persons = 12 x 600 = 7200 p.y
- Every 1 or 2-persons household receives 300 Home-valuta.
Every extra individual 150 p. month extra.
- Resorts for commune receive 150 Home-valuta per inhabitant, monthly
- Home-valuta is a deposit in a special bank-account for housekeeping = rent / mortgage / energy/ insurance / renovation costs...etc..
- A Home-valuta Inspector checks on the way the budget is spend, every year =

Individuals receive 'a healthy income for a good house, but have to prove that standard costs of living are paid in time, with the Inspector of the Tax-office'.

- Housing corporations have to prove that they 'obey the HR- & Nature-treaties'= make houses part of the HN-economy = less pollution and waste of energy. Do they refuse to cooperate?

The government punishes the housing associations by taking away their budget and give it to builders, who take care of the necessary renovations for HN-houses.

- Every individual -found guilty of fraud with the Home-valuta – loses 25 % of the budget for the period of 1 year or gets a 240 work in slavery for the government. The Arbitrator-judge decides which punishment is applicable. Chair-persons of associations get an individual punishment, from the moment they spend the budget incorrect = steal money from the budget for other purposes. In a table the Arbitrator-judge finds the correct punishments for the crime.

Voor NL zijn Leef- & Woon-valuta

Life-valuta = 16,5 miljoen x 6000 = 99.000.000.000 p.jr.

Home-valuta = 6.5 miljoen huishoudens x 7200 p.jr = 46.800.000.000 p.jr.

Members of parliament are in control of the national HN-budget

- Decide on the individual budget for Life-valuta & Home-valuta every year
- Decide on other budgets
- Decide on minimum prices and freeze prices voor organisations
- Check on HN-economy in organisations & stock exchange
- Write HR- and Nature treaties
- Are in control of national, continental & intercontinental HN-economy

HR-treaties. 2 Types = continental & intercontinental

- HR-treaties stay or are transformed into intercontinental treaties
- Every policy the government publishes is anchored in HR
- Every individual is obliged to use HR in daily life
- The Arbitrator-court judges on the performances of all= government, organisations & individuals
- Judges are obliged to use HR in their verdicts, including uniformity of law
- Exchange of verdicts, Worldwide in a database.

Nature-treaties. 3 Types = national, continental & intercontinental

- Every country still lives 'on their own level of science'. Every nation writes N-treaties for their national level of science. These will be synchronized with the already existing treaties for continents or the World.
- Every 10 year a N-treaty is upgraded with 'new science'
- So, we get a Sun-treaty, Wind-treaty, Water-treaty, Fire-treaty, Soil-treaty, Raw materials-treaty, Forest-treaty, Animal-treaty, Farmers-treaty, Fish-treaty, Medical technology-treaty...etc..
- Individuals are obliged to execute these N-treaties in the best suitable way possible
- Arbitrators-courts judge in conflicts. tables for punishment are published for the public.

Economical treaties. 3 Types = national, continental, intercontinental

- Current E-treaties have to be synchronized with HR- and N-treaties
- There will be company-treaties for (public) transport, energy, employers-attitude, employees-attitude, trade unions, arbitration...etc... Standards of science are foundations.
- 10-20 Year after execution of the HN-economy these treaties must be available in good practise.
- In 2028 HR, Nature & Economics are balanced?

HN-economy-ethos

Labour-ethos is removed from the community, unemployment no longer exists.

HN-ethos stands for 40 hr compelled participation per week in the community, Worldwide.

A labour-day is max. 8 hrs = 6.5 billion people want to work on a healthy planet We have to divide tasks.

When individuals work 'too much' they get a 'watch-punishment'= 240 hr watch others work...

Differences between education, business, healthcare, community disappear as much as possible. Each organisation provides in every aspect of life.

5 Types of contracts for the HN-economy-ethos, with 40 hr participation per week

- Care-contract = for taking care of 1 person, you get a 20 hr care-contract. For every person extra, you get 10 extra hours. Thus: 1 parent with 4 kids does not have to sign others HN-ethos-contracts.
- Labour-contract = 40 hr work without care, study of traineeship
- Traineeship = every teenager from 16 years studies and works
- Study-contract = the individual can study with every employer, parttime or fulltime
- Volunteers-contract = every individual who wants to live of the minimum-basic-income in the HN-economy for Life - & Home-valuation.
They can work as volunteers in all organisations and receive an extra 1500 euro volunteers-payment, per year.

Supplement to the HN-economy-ethos-contracts

Volunteers-contract for 'all officially unemployed'= individuals who do not receive a Salary-valuation on a labour-contract. When they start to work as a volunteer, they receive the extra 1500 euro per year.

For home-offices too!

Thus all individuals who now live of a 'industrial disability-insurance' get this contract. Sickness, reporting ill, syndromes, sick leave, absence through illness...etc... is described in tables as much as possible. So, everybody knows 'what sickness is'. Individuals can go to the Arbiters-court with conflicts.

For industrial accidents, extra income is arranged in the Collective Labour Agreement. In all cases of industrial accidents, the Arbiters-court must judge the situation.

Civilians are free to decide 'what contract they need'. Restarted in the municipals HN-ethos-bureau.

Members of parliament and government are still in control of all budgets, resulting in LESS bureaucracy, more labour-activities... and less civil wars.

Parliament imposes a personnel-quota on employers = balance between various contracts in Collective Labour Agreements per branch.

In spare time, people are free to do what they need, as long as it's produced in fair trade...

Example: Car-racing is still permitted, but you have to use 'war-free fuel'. Flying is oké, but only in a pollution free aeroplane.

Employers

- Simple payment-construction
- Employers pay only the 500 Life-valuation per person 'back to the HN-treasure chest'.
- Home-valuation is not paid by employers
- Every employer pays 100 HN-ethos per employee per month to the HN-treasure chest = don't dump personnel in disability insurances...
- Every employer pays a 100 Pension-valuation per employee per month to the employee self.
- Every employer pays 100 Sickness-valuation to the HN-treasure chest per employee per month.
- When an employee 'needs more luxury' he / she has to pay for it from the HN-basic-income plus salary.

Employers will keep a regular income throughout their lives = no homeless people anymore, no poverty, less sickness.... and less natural disasters...

Maximum 50 salary scales on planet Earth

- Every scale increases with 200 Salary-valuation for a start.

So, employers pays 500 Home-valuta to the HN-treasure chest and 100 Salary-valuta to the employee. Or 500 S-valuta, or 4900 S-valuta...

- Stock-exchange is only used for 'balancing the HN-economy, a toy what can make good investors very rich!
- 50% of the HN-compagny-profit must be invested in the own organisation, within a year.
- 25% for speculations on the stock-exchange
- 25 % reserve
- Organisations get 'a lot of personal freedom', on the condiction that they invest in the HN-economy.
- Licences for the execution of HR- & Nature treaties are still required. Safety & Security. Uniformity. National government only requiers licences from compagnies if absolutely neccesary for national security or science.
- Punishments are SEVERE – DOWN LOADED from HEL-, from the moment the compagny refuses to produce the HN-economy. Licences are nullified by the government, temporarily.
Compagnies visit the Arbiters court. The Arbiters-judge decides 'what to do'. For example: 1 year no acces to the Stock Exchange, imprisonment, individual work in slavery 240 hr.
- When crimes against humanity are involved, the Arbiters court sends the file to the Criminal court. Or police and prosecuters make sure that the file – and people involved – are brought to trail with the Criminal court.
- A table tells us 'which punishment under what circumstances'. Judges choses the kolom.
- Employers & employees agree in Col.Lab.Agree. on the mixture of the 5 contracts.
- Study is a natural part of Evolution of Life. Compagnies don't go bankrupt ...? So organisations provide in a 'life-long-study in a mixture with labour-tasks'. System? See Open University

Studypassport = every individual studies from 2 until 67 year:

Playground is obliged from 2 years old. During 1 life-time every individual is entitled to a University-study, financed with HN-treasure chest money... But....!?

- Individuals get a studypassport for the registration of all study and jobs
- HN-ethos-buro in every municipal is responsible for this S-passport

Primaryschool for kids from 2 -15 year

- Education is aimed at fair trade
- Intercontinental HN-educationbudget is 10.000 eur per kid per year.
- Adults take care ofkids up to 16 as kids, no longer as 'key-kids'.
Asults need to learn to love kids again, and live together with them throughout the labour-week.
- Schools are small communities of max 200-400 students per school.
- Every kid of 4 years and older receives a personal 'confidential' workbook of the School Support System, for Results of Evolution. Tests. Every kid can work on the level best for its health.
- Every kid of 16 gets a 'study-instruction for higher education'. Career-advice.
- At school, all kinds of people work = parents, pensioner-profs, disabled persons...etc...
On a volunteers-contract. School as an open education system makes it easier for parents to combine care with study and extra payed labour.

Teenagers from 16 year and older get 'career-education'

- Education-budget per person is 10.000 euro per year from playground to university
- 16 Years and older study in the Open University System, together in a schoolbuilding.
- Every course for which they graduate is registarted in the S-passport.
- Career-education is free, but needs an investment = Kids from 16 sign a schoolcontract for High-school or University. 4 Days study + 1 day work. Young adults learn 'how to run a 1-persons-toko'. Young adults who work 4 days and study 1 day, have to invest in the study-costs first. After they have registered their certificate, they get the investment repayed from the S-passport buro.

Higher education

- Students invest in study costs first, get a repay after they have registered their certificate.
- What do you want to study? Look on websites of companies. They instruct you on 'what to study for which jobs'.
- Inspectors for Higher Education check on the study-standards: profs, books, HN-economy...etc...
- 'Unemployed students' - truants – go to the Arbiters court for a 240 hr study in slavery = punishment, on command of the Inspector for Higher Education.

Interncontinentale organisations

Every country & continent opens a HN-economical office and HN-legal system. VN, EU, Liga...stay

Financial flows

- Every country has a Home-bank for registration of the HN-economy
- Every continent has a Continental-bank for synchronization of Home-banks
- Planet Earth has a World-bank for synchronization of all continental-bank
- All banks publish budgets & spendings on the internet!
- HN-budget are presented to the public during election-time and executed in government-policies
- The largest political party who wins the election is in control of the parliament
- Lord of the jungle can no longer exist = national law is obliged for municipals too
- Budgets & spendings are published on the internet and up-dated every 3 months
- Residents get an 'internet-referendum-right' on every 15th of each month = they may vote on-line for spending of budgets. Use passportnumber as ID. Voting-system: Januari = healthcare. February = education. March = (public) transport...etc... i
- Because all banks & budgets are synchronized, information doesn't disappear during nature disasters = budgets to transform a disaster into normal live again, are published and stay published, what ever happens
- All banks may publish advice 'on how to improve our HN-economy'.

Political institutes

- Established institutes continue their core-business for social-structures in communities
- Social-procedures behind the financial HN-economy. Uniformity of international law.... Synchronization of database per nation, continent & interncontinental
- A think-tank in every nation, for higher standards for social-structures = reports are published on-line.
- Every country, continent & interncontinentaal 'opens budgets for HR + Economical rights + nature disasters + defence + universe & space travel +etc... Every country deposits 1000 euro per resident in every budget per year, for science, transform disasters ...etc.... Budgets & spendings published on-line.
- Defence gets a special assignment = to protect planet Earth during 'transformation from 'a licence to kill economy' into a HN-economy & rescue-operations'.

For balancing the HN-economy - every nation, continent & intercontinental – we open a inherent budget

All countries deposit 2000 euro per resident per year in all 3 budgets.

Stock-exchange has to transform from 'a licence to kill system' into a 'I want to save your life & neighbourhood system'.

We execute on a high speed road:

- (medical) technology for balancing human body with nature
- implementation of solar-energy on a large scale, Worldwide
- growth process for raw materials & recycling-industry
- social-structures
- individuals – now unemployed – are trained for a job on this high speed HN-road
People who suffer from illiteracy, go to school. Persons who can study are up-graded. We re-arrange tasks. Every individual – who works together in this system

– receives the HN-basic income = Life- & Home-valuta. Conditions: you must only buy 'fair trade'.

persons who refuse to work in the HN system are cut with 25 % on their HN-basic income for 1 year = 'they chose to live in poverty, while their neighbours balance their lives & budgets'.

- Thanks to the HN-basic- income, persons who need to move to a region for work, can actually move and start to work for a new lifestyle & planet.

I can't explain all my ideas here. I have to skip to the New Legal Frame

New Legal Frame = balance in power amongst residents - government – legal system & media

In every municipal of 50.000 inhabitants, we open a Arbiters-court. Remove the Administration court. Re-arrange legal procedures.

3 types of court

Criminal court

- crimes go to the criminal judge directly. Victims & perpetrators are granted with a lawyer
- judges work with tables for punishment = judges chooses kolom out the table
- we also publish law-tables for 'to pay damage to victims' after all legal procedures are closed

Arbiters court

- we work with Wetboek voor Burgerlijke Rechtsvordering
- all conflicts concerning the HN-economy are judges here
- participants are not obliged to use the services of a lawyer
- participants are expected to come to conflict-ending after one hearing / verdict = tables for fines & penances
- when participants refuse to obey laws and do not wish to end the conflict 'the Arbitrer-judge turn them over to the Criminal judge' = punishment for torment & crimes
- 2 official-judges & 1 resident-judge per file
- resident-judge signa a contract to prove 'that he / she will obey all (international)laws available'
- during the first hearing the file is appointed to the correct court for the case
- courts are open for public
- individuals are not obliged 'to violate HR'= payment for doing so is 25 % of HN-basic income per individual = no distinction between residents , inhabitants or public servants or politicians anymore

Family court

- for all family matters

Inspector for NLF-planet

We need a new Inspector who checks on the NLF-standards of every individual who works in the legal system.

Rich or poor may lodge complaints per department

- **National courts of law, after all possible lawcases are closed and judges appear to be 'dictators, guilty of crimes against humanity'.**
- **Head-officie of Police, when complaints are not solved**
- **Head-office of Prosecutor, when they refuse to investigate 'crimes against humanity'**
- **Lawyers-offices**
- **Political parties who refuse to read lawcases concerning 'violation of HR- & nature rights'.**

What did I gave you, today?

**I gave you an inside look in our EU-pro-war system in Holland
