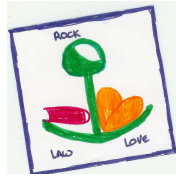

- for assisting the Dutch Cabinet, Parliament, Monarchy & Lobbyists of the NL Thehaguesecuritydelta with torture and a murder attempt on my body and for torturing & killings civilians via my body. The MH17-passengers died on 17july2014 above Ukraine due to warcrimes conducted by Nato-members.

Below listed Nato-members always have ignored the fact that I started an ICC-lawcase against NL on 1may2007. This is a warcrime on their behalf. The fact that ICC tortures me and torments terrorists and criminals via social media is a warcrime on behalf of ICC-staff.

The UN-charter obliges Nato-members and UN-members to conduct the Humanright-treaties every second of a day on Planet Earth. The Washington-treaty is founded on top of the UN-charter and prescribes the methods of work for Nato.

The Torture-treaty and every Torture-articles in Humanright-treaties ensure that a single person or organisation disconnects from other single persons or organisations who refuse to conduct the UN-charter, HR-treaties, Constitutions and National laws founded in Humanrights.Torture-treaty and Torture articles in HR-treaties ensure the people on Planet Earth that Fun-killings under grave misconduct of rulers can not take place.

Nato has received and ignored emails about my ICC-lawcase, published on my websites and on CD for ICC.

Nato-members had the legal obligation to command New Elections for the NL-people from the first moment they learned that former Prime Minister J.P. Balkenende tortures Dutch Nationals with the aim to mob them death and that DesireeStokkel had started an ICC-lawcase against NL in order to stop these practises. Nato-authority from 10may2015 on:

From 10may2015 on, Nato no longer exists as an Institute that provides in Humanrights, National security for its members, European Security or International Security and the People on Earth.

Nato must be closed down instantly.
All Nato-activities must be stopped immediately.

Nato can be cleaned up, what requires that its members clean up their National Cabinet, Parliament and Monarchy too.
Current listed Heads of States, Heads of Government, Nato Ministers of Foreign Affairs, Ministers of Defence, Permanent Representatives are all to be replaced by new persons who do implement and conduct the UN-charter and Humanright-treaties legally correct.

I have kept the Nato Ministers of Foreign Affairs in their job , so they can clean Nato up. After cleansing they must resign and leave politics.

In daily reality this means that Nato has only 1 task left, namely:
'Realizing that every UN-member conducts that UN-charter legally correct so people get acces to Nationals Courts of Law for Conflict-ending without violence on Planet Earth'.

The Washington-treaty was written in 1949; it can be schreddered.

My demands:

I want all above listed persons to be convicted to one year in ICC-prison for organizing and conducting torture & murder – on my body, the MH17-passengers and Planet Earth – in cooperation with the International Criminal Court, NL-Cabinet, Parliament, Monarchy, Judiciary Council, BarAssociation, Legal Aid Council. In the media is announced that our NL-intelligence service MIVD wants NL to see China as our enemy. I know that NL misuses Nato – Baltics for starting wars, because they want to put the blame on Putin - Kremlin for all that goes wrong in NL.

According to the Torture-treaty I am entitled to the labourcontract of Prime Minister of the Kingdom the Netherlands. The Min.CommonAffairs – PaulHuijts & co – have no intention to give me this contract = they want me to fight for this right = they want a civil war in Europe. They are insane. They start wars for fun...

I do want this labourcontract for PM of NL.

Than I will rule by decree the implementation and conduct of the new Constitution for the Republic Netherlands.

I want new elections for the parliament – an elected Prime Minister & vice-President for NL and 225 newly elected politicians who do conduct that Constitution UN-charter and HR-treaties –. After this election I want to hand over my task as PM for NL to the newly elected President.

ICC is a giga- warmaker internationally.

Due to ICC-NL-DICTATORCLUB-corruption Terrorists – Criminals have grown in number and violence all over the World.

Current statemembers of the Statute of Rome, the UN or EU have refused to help me turn ICC into a fair courtsystem to stop wars with.

- Kuwait ICC-assembly statemembers – president

All new ICC-staff members must be young persons, age between 21 and 40 years.

They must have a University degree in Law or Economics.
They must be able to prove to the people of Planet Earth that they did study Law or Economics.
They must be independent from the UN-EU-lobby, internationally.

They must be prepared to conduct the UN-treaty, Humanright-treaties and my NL-Constitution for Republic Netherlands, legally correct.

They must be prepared to take the Torture-treaty to clean up ICC from the inside out
= remove all staff that supports the ICC-NL-dictatorclub.
