Dmitri Medvedev,

This letter is sent by mail to you.

You have made the wrong decision in connection with my ICC-case against NL. Because you don't respond officially to my letter of 8 aug 2008 - only use my websites in your speeches/talks - you have given NL-parliament & ICC-employees the opportunity to become more violent. They have taken it up, gratefully.

War-crimes in NL intensify

When you would have given me written evidence that proves that the Kremlin wants ICC to be a fair court of law, Rotterdam city would not have a war-criminal as Major today. mr. A. Aboutaleb should have been stopped by AIVD, NCTb, ICC - now he's a suspect/perpatrator in an ICC-case - but he's now the most powerful person in mainport Rotterdam. Distribution-centre for Europe. Based on our NL-constitution Aboutaleb can no longer put criminals/terrorists in prison. Nobody can stop terrorism in Rotterdam officially, anymore. Min. of Internal Affairs ignores my ICC-case, so do Balkenende & co. Min. of Foreign Affairs & statesecretaries do not respond to my letter in which I press charges against him for the making of terrorism in NL.

When ICC would have been honest about this ICC-case against NL in june 2007, we would have had new elections for parliament in NL

- = would have had a more fair parliament today
- = would have had more fair local councils today in NL
- = Schiphol Airport, Rotterdam mainport and similar organisations would have been better protected against war too.

NATO would have been more honest about tasks. So would have EU & UN. Even the financial crisis would have been 'lighter', because hidden war-lords would have get the messages: 'War-lords can be put in ICC-prison after all'. Media would have published truth.

Georgia would not have happened. Bush would have been slowed down. Barack Obama would have been elected to President of USA anyway.....

Dmitri, do you get the picture for a life without military means?

When I wrote my ICC-paper of 1 sept 2007, I already knew 'that ICC was 100% corrupt'. There are No systems at all! I am a Dutch woman, not some stupid desert cow....

- Prosecutors & UN-employees decide together in dark deals 'which dictator is to be brought to trail, which is free to stay in a powerful position in politics'. The rest of the world is excluded from these deals. Consequences are irrelevant for deal-makers.
- ICC-judges have No system to stop these war-crimes of prosecutors & president = they write a verdict/degree after a dictator has been brought to trail to prove 'ICC-employees are fair after all'.

Thus, ICC-war-lords put people in prison and write degrees to prove that they never have been war-lords in the first place.

I wanted to give prosecutors & president time to 'undo' their mistakes.

In may 2007 I have given ICC-judges the opportunity to 'undo' their mistakes = prove that ICC works with fair legal systems after all. But now prosecutors, president & judges ignore my ICC-case against NL, while they know Taliban and 'so called Terrorists' read my websites.

ICC-employees do not care for the fact that they torture, kill, cause terrorism & war; national or international. EU & UN lie when they write me: 'We can't intervene'. They don't want to do the hard work, thats all...

I feel sick
